Keeping the above in mind, I do commend the efforts of our Athletes, Administrators and Officials for the many achievements in 2014, including the performance of our Team PNG in the Glasgow Commonwealth Games.

As mentioned in the Annual Report, the highlight was undoubtedly the two gold medals through our weightlifters Dika Toua and Steven Kari - A truly historical achievement for the nation placing Papua New Guinea 16th on the medal tally out of 71 nations.

They follow in footsteps in other gold medalists, Geua Tau in the 1990 Commonwealth Games in Auckland, New Zealand and Ryan Pini in the 20016 Commonwealth Games in Melbourne, Australia.

Congratulations to the Chef de Mission, Emma Waiwai and her Management Team for their efforts in ensuring that all of our Athletes perform to their optimum best resulting in many

personal bests including breaking National Records. This augurs well in their Pursuit of Excellence with the Pacific Games as their next target.

Part of our new dawn is aimed at realizing our longtime vision of a future home, the PNG Olympic 'Haus' for our Members, with the assistance of the PNG Sports Foundation and Honourable Minister for Sports, Hon. Justin Tkatchenko.

I would also like to thank my fellow board members for their dedication and commitment to their responsibilities. We are going through a time of major changes in our organization as well as our country and your commitment to the role of the PNGOC is very important in the development of sports and most importantly our athletes.

2014 was indeed a full and exciting year for the PNG Olympic Committee. Preparations for the 2015 Pacific Games continued in earnest as we embarked on the final year before the Games.

The highlight of the year was Team PNG's success at the Glasgow Commonwealth Games finishing 16th out of 71 countries. I take this opportunity to congratulate Team PNG particularly our two gold medallists, Dika Toua and Steven Kari.

Synonymous with the sport of weightlifting is Trukai Industries, and it is with much gratitude we acknowledge their contribution to Team PNG through our nation-wide Trukai Fun Run.

Momentum picked up in all aspects of preparing Team PNG through the Government funded "Go for Gold" Program as national squads went through intense programs of much needed competitions and training.

SP Brewery stepped in to boost Team PNG's gold medal campaign with a contribution of K1m funding for the "Gold Athletes Program". We thank the Board and Management of SP Brewery for this generous support.

To support the Chef de Mission, a full time General Team Manager for Team PNG was recruited to provide dedicated administrative support in putting together the largest possible PNG Team competing to the best of its ability in the 2015 Pacific Games. The General Team Management and Medical Team for Team PNG were also finalised in the third quarter of 2014.

There is an enormous sense of expectation for Team PNG to succeed at a home Games, and PNGOC has responded to these expectations with an expansion to include a High Performance Division and program to build capacity of coaches, trainers and managers supporting athletes to perform to their optimum best.

A major milestone was the establishment of the High Performance Training Centre made possible through the "Go for Gold" Program. This facility provides the necessary support and high performance services, which no doubt plays a hugely important part in the preparation of our Team PNG athletes for 2015. We are extremely grateful for the Government's support in realising this strategic priority set out in our current Strategic Plan.

Our athletes now have the opportunity to train in a world-class facility and be exposed to up-to-date practices in sports science.

The Athletes and Officials Selection Policies for the first time were developed and endorsed by the PNGOC Board to select the best athletes and officials to represent Papua New Guinea on home soil.

The PNG Athletes Commission, one of the most active Commissions in the region

continued to run their Voices of the Athletes (VOA) Program at key events including the PNG Games held in Lae. This year marks the final year of the Athletes Commission's four-year team and I would like to acknowledge the work of the AC members led by Alex Davani and Karo Lelai for their outstanding contribution representing the athletes of PNG.

Our other programs continued with much needed support through grants from Olympic Solidarity and Commonwealth Games Federation preparing our Teams for the Glasgow Commonwealth Games and 2016 Rio Olympics.

2014 also saw the participation of our young team of athletes who proudly represented Papua New Guinea at the 2nd Youth Olympic Games held in Nanjing, China two weeks after the Commonwealth Games.

Thanks to all of our member National Federations for your continuing support and partnership with our journey to 2015. The PNGOC Board and Management greatly appreciate your trust and encouragement to represent you.

We are pleased to acknowledge the significant support of the Government of Papua New Guinea through the 'Go for Gold' Program. This extends to

positive working relationships with the Minister for Sport and the PNG Sports Foundation.

Our valued corporate partners, all identified further in this report, continue to support PNGOC and our direction, which is always encouraging. Their contribution provides the means to allow the PNGOC continue its pursuit of excellence.

Secretariat Report



With the XV Port Moresby Pacific Games on the horizon, 2014 was an extremely busy year for the Papua New Guinea Olympic Committee (PNGOC) as our efforts to support the preparations of the country's elite athletes for the Games added another layer of importance to the delivery of our activities.

New location and developments

In addition to the implementation of programmes, the PNGOC also went through office relocation as a result of the work carried out on facilities for the 2015 Pacific Games. The organisation left its home of just over three years at the Sir John Guise Indoor Complex in April 2014 and made the move to its current home leading into the Pacific Games at the Telikom 4-mile compound in Boroko. The move also resulted in the opportunity to secure a warehouse facility in the same compound for the PNGOC High Performance Training Centre. By the end of the year the PNGOC had settled in to its new location with minimal impact to its operations. We look forward to post Pacific Games, when we will be able to resettle into a permanent location which will hopefully become the future Olympic Haus.

XX Commonwealth Games—Glasgow

A magnificent milestone for the PNG Olympic Committee came through Team PNG's performance at the Glasgow Commonwealth Games where we sent a total contingent of 140 (96 athletes and 46 officials), Team PNG's largest number of athletes to compete at a Commonwealth Games to date. Team PNG athletes competed in athletics (able bodied and para-athletes), boxing, judo, lawn bowls, para-powerlifting, rugby 7s, squash, swimming, table tennis, triathlon and weightlifting. The team finished a wonderful 16th out of 71 nations on the medal table, our most successful result at a Commonwealth Games in over 50 years of attendance.

Notable performances from Team PNG in Glasgow included Toea Wisil making the semi-finals in the women's 100 and 200 metre sprints. Boxer Charles Keama made it to the quarter finals and Elias Larry made the final in the T37 category in the para-athletics 100 metres.

Undoubtedly however, it was the fantastic results of PNG's two weightlifting superstars Steven Kari and Dika Toua, who won gold in their respective divisions that was the biggest highlight. This was the first time Team PNG had won two gold medals at the same Commonwealth Games. Steven and Dika join Geua Tau and Ryan Pini as PNG's only athletes to win gold at the Commonwealth level.

Their feat was recognised by the public upon return as the team was welcomed back with a rousing reception and a parade through



the streets of Port Moresby. The two gold medal champions were also generously rewarded by the Prime Minister and Government of PNG with K100,000 kina each for their triumphant efforts.

2nd Youth Olympic Games—Nanjing

2014 also saw Team PNG attend the other major international event on our calendar, the 2nd Youth Olympic Games which was held in Nanjing, China. The Youth Olympics Games with its emphasis on both competition and connection amongst the world's best young athletes saw Team PNG's elite young athletes not only have the opportunity to compete with their peers, but also experience different cultures as part of the game's DNA.

The Youth Olympic Team saw PNG represented in the sports of Athletics, Football, Swimming, Sailing and Weightlifting. The team achieved four personal bests with Dwayne Koroka in the men's athletics 200 metres, Igo Lohia in the men's 62kg weightlifting and Colin Akara in the men's 100m and 200m swimming freestyle. The under 15s women's football team also won their first international match at the Youth Olympic level when they beat Namibia 3-2 to claim the fifth spot in the tournament.

Team PNG's focus on the 2015 Pacific Games was augmented with the appointment of the Chef de Mission and the General Management Team for the Games. Richard Kassman, the CdM for Team PNG to the 2013 Wallis & Futuna Pacific Mini-Games, has been entrusted with the task of leading Team PNG once again for our home games. He will be assisted by

the General Manager for the team Leith Isaac who will be managing what will be Team PNG's largest ever team to an international sporting event.

Progress towards the 2015 Pacific Games over the last year has seen the endorsement of the Team PNG sports officials through the PNGOC Officials Selection Policy. A similar policy for the selection of Team PNG athletes for each of the 28 sports on the 2015 Pacific Games programme was finalised and shared with sports for use in the selection process. A majority of the coaches and managers who lead our sports have been selected by the end of 2014.

The PNG Olympic Committee has had a long standing ambition to provide PNG's elite athletes with a facility to support their elite performance needs. In July 2014, this goal was achieved when the High Performance Training Centre (HPTC) was officially opened by the Minister of Sports and the 2015 Pacific Games, Justin Tkatchenko. The venue is free of charge for Team PNG athletes and provides them with access to strength and conditioning equipment and expertise from local trainers as well as access to sports rehabilitation and sports science services in the form of physiotherapy and massage service.

At the end of 2014, the HPTC had 18 local staff involved in training PNG's best athletes. In addition to training their athletes, the High Performance division have also helped coaches from the respective sports develop their periodization plans and impart knowledge on proper warm-up and warm-down protocols.

The establishment and running of the HPTC has been a large focus of PNGOC's High Performance Division, however PNGOC's efforts in the high performance area in 2014 has also seen the staging of a National Coaches and Managers Conference and two level sports trainer courses to develop the capacity of those involved with elite sport in PNG.



The preparation of the athletes of the twenty-eight sports on the 2015 Pacific Games programme escalated noticeably in 2014. The establishment of and the attendance at the HPTC together with the increased involvement in various preparation activities by targeted Team PNG athletes has been possible through the Go For Gold Programme.

The Go For Gold funding provided by Government has been vital to the 28 sports on the 2015 Pacific Games programme, allowing them to take part in international tournaments, stage training camps both domestically and overseas, have access to coaching expertise

not normally available and assist with logistical and administrative matters. The table below shows the category of activities support through G4G funding for each sport in 2014.

Highly valued Olympic Solidarity funding was utilised to support athletes preparing for the Youth Olympic Games, as well as support Sailing, Weightlifting, Athletics, Swimming and Judo with specific activities. The newly established PNG Handball Federation was also supported with funding which saw PNG take part in its first ever international handball tournament at the Oceania Youth Handball Championships in New Zealand.

Olympic Solidarity funding was also used to support the staging of the 6th national PNG Games, held in November in Lae. The funds allowed for technical officials to be flown in to the Games and take part in refresher courses before officiating at the Games which saw over 7,000 participants representing their provinces from across the nation.

The PNG Olympic Committee, through the PNG Athletes Commission, also ran the Voices of the Athletes programme at the PNG Games. It was the first time the VOA programme has been staged in Papua New Guinea and saw the athletes attending the games engaging with the programme through an interactive style of awareness on four components: *Be a Leader* – promoting the role of athletes as role models and leaders in their communities; *Play Safe* – HIV and AIDS awareness; *Play True* – focusing on the impact of drugs on athletes and sporting competition; *Go Green 'Love your Coast'* – the impact of plastic rubbish on the marine environment and human health. The VOA programme was also supported by the Sports HIV Committee through funding and personnel.



The focus on having women equally involved in and represented in sport was seen through the appointment of Emma Waiwai as Chef de Mission for Team PNG to the Glasgow Games in 2014. We were also proud of the efforts of female athlete Dika Toua winning Gold at the Games. A number of female staff are now employed by the PNG Olympic Committee as well as the new High Performance Training Centre staff. Out of the total staff in the PNG Olympic Office 40% are females while in the High Performance Centre 47% are females.

PNGOC was also proud to have Secretary General Auvita Rapilla elected to the ONOC Executive Board in 2014 and was appointed to the ANOC Executive Board, notable recognition of her work in the Olympic Movement.

The PNG Sports Anti-Doping Organisation held a workshop for National Federations in June with the assistance of the Oceania Regional Anti-Doping Organisation. The anti-doping workshop was made possible through its UNESCO Regional Application Funding and took sports through issues related to drugs in sport and updated them on recent changes to the

The SP Sports Awards held for the 22nd time in 2014, saw PNG's sporting personalities rewarded for their exploits. The three big awards went to Steven Kari as Male Athlete of the Year, Abigail Tere-Apisah as Female Athlete of the Year and the PNG Barramundis as the Team of the Year.



The PNGOC is grateful to all those who took part in our very successful major fundraising events. The Trukai Fun Run and the Prime Minister's Corporate Golf Challenge drew large numbers of participants in 2014 and are expected to be bigger in 2015. We are looking forward to the staging of the Trukai Fun Run next year, which will be held on July 5th, 2015 – a day after the opening ceremony of the Pacific Games.

The Trukai Fun Run continued to grow in 2014, with 95,000 shirts supplied to PNGOC by Trukai Industries. The June 22nd event involved 10 centres from around the country as the PNG public, schools and business houses again showed their fondness for what is recognised as the Pacific's biggest event of its kind. Over 50,000 people participated in the fun run in Port Moresby alone.

The corporate community in PNG showed their great support again for the annual Prime Minister's Corporate Golf Challenge with 54 Teams participating in Port Moresby and another 34 teams in Lae. NCDC were the winners in Port Moresby while Goroka Coffee Roasters took out the title in Lae. PNGOC thanks the Royal Port Moresby Golf Club and the Lae Golf Club for hosting the golf challenges.

With the success of Team PNG, our activities and programmes, PNGOC is grateful for the support of our partners, sponsors and stakeholders who continue to make everything we do possible. Our gratitude is extended to the National Government, the Ministry of Sports and the Sports Foundation for the valued support. The PNGOC is deeply indebted to our sponsors, National Gaming Control Board, Trukai Industries, Air Niugini, SP Brewery, Pacific MMI, The National, Coral Sea Hotels, Remington Print and Document Solutions, Theodist, IBS, Courts and Media Partners for providing the means to allow the PNGOC continue its pursuit of excellence.





FINANCIAL STATEMENTS

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Papua New Guinea Olympic Committee Inc. is an association domiciled in Papua New Guinea. The address of the associations' registered office is at Sir John Guise Stadium Port Moresby, National Capital District Papua New Guinea. The association's principal activity is a non-government organization that represents the interests of its members, the National Sports Federations.

The Papua New Guinea Olympic Committee Inc. includes the National Olympic Committee, The Commonwealth Games Association, The Pacific Games Association, and the Fund Raising Committee.

The financial statements were approved at the Executive Committee Members Meeting held on the 7 May 2015.

Subsidiary

The Papua New Guinea Olympic Committee Inc. owns 100% of the PNG 2015 Pacific Games Organising Committee, PNG 2015 Pacific Games Ltd. The investment in subsidiary is shown at cost.

Basis of preparation

The financial statements have been prepared in accordance with the Associations Act (Chapter 142). The financial statements are based on the historical cost and do not take into account changing money values or, except where specifically stated.

(i) Special purpose financial statements

This is a special purpose financial report for the sole purpose of providing financial information to the members and must not be used for any other purpose.

The association is an exempt organization in accordance with Section 171 of the Companies Act 1997 as the members have elected to be exempt under Section 171 (1b).

As the association is an exempt organization it has taken advantage of the exemption provided by the ASB from complying with:

- IAS 12 – Income Taxes
- IAS 27 - Consolidated Financial Statements and Accounting for Investments in Subsidiaries
- IAS 32 - Financial Instruments, Disclosures and Presentation

(a) Presentation of financial statements

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, and have been applied consistently by the Association.

(b) Foreign currency transactions

Transactions in foreign currencies are recorded at the exchange rate at the date of the transaction. Foreign currency monetary assets and liabilities are translated at the exchange rate at the balance date. Resulting exchange differences are recognised in the profit and loss account for the year. Non-monetary assets and liabilities denominated in foreign currency are recorded at the exchange rate at the date of the transaction.

1 SIGNIFICANT ACCOUNTING POLICIES (continued)**(c) Property, plant and equipment**

Items of property, plant and equipment are stated at original cost less accumulated depreciation and impairment losses.

Depreciation is provided on cost amount of all fixed assets, including buildings so as to write off the assets progressively over their estimated useful lives. Fixed assets are first depreciated in the year of acquisition.

The straight line method of depreciation is used and the rates of depreciation used are :

Office equipment		30%

(d) Impairment

The carrying amounts of all assets are reviewed at each balance date to determine whether there is any indication of impairment.

(e) Inventories

Sports wear and accessories purchased for past Olympic, Commonwealth and Pacific Games, but not yet used are valued at the lower of cost and net realisable value.

(f) Provisions

Provisions are recognised when the association has a legal or constructive obligation as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation.

(g) Taxation

The association is exempt from income tax under Section 27(b) of the PNG Income Tax Act as a sporting body.

(h) Revenue

The major source of revenue for the association is grants and sponsorship income. Revenue is recognised when the funds are received.

(i) Provisional Reserve

The association allocates grants and sponsorship income to individual projects. The excess of such allocated income over expenditure are transferred from the Statement of comprehensive income into a "Provisional Reserve" and included as "Funds held in Trust" in the Statement of financial position.

Football Activity Report



Papua New Guinea Football Association

As OFC President and FIFA Vice President the vision to promote football as the number one sport throughout the country and to develop Papua New Guinea into a leading football nation in the Oceania region is an ongoing priority for David Chung and the Executive Committee.

PNGFA has implemented many new initiatives this past year including the launch of Meri Football, the Elite Academy programmes, and centre's of excellence and the approval for the Less Privileged project in Bougainville plus many more.

2013 and 2014 have been a successful years for Papua New Guinea Football Association recording many positive achievements which were complemented by some telling results on the international stage.

FIFA Goal Project

In Kimbe, West New Britain Province the new technical centre with changing rooms and an office facility and two international size fields are now complete. In March, the West New Britain Governor honoured his commitment by presenting K1 million as its counterpart funding for the construction of the second stage. In the second stage, a 20-room accommodation complex and amenities building with a gymnasium is currently under construction.

It was an historic occasion for the people of the Autonomous Region of Bougainville when PNGFA President David Chung officially put a stick in the ground to let work begin on the Emiovi Bougainville Football Academy at Manetai in September. The new programme is part of FIFA'S Less Privileged Programme and a first in the region. Further projects are planned for 2015 onwards.

The Telkom National Soccer League

The Telkom National Soccer League continues to lift the standard of football in the country and ultimately produce a higher level of performance at OFC tournaments.

The 2013 and 2014 seasons once again had Hekari continue to dominate proving too strong for all-comers.

The year also marked the presentation of K1 million from the Telkom PNG Limited to NSL Board Chairman, Isaac Lupari and PNGFA Vice President, Linda Wonuhali for the kick-off of the NSL 2014 season.

After finishing second in 2013 and its highest position in the programme's history, the Besta PNG Utd National Development Team fielded a much younger squad targeting U20 players for the National U20 team. Besta PNG United FC has received great support from International Food Corporation Ltd, Lae to whom we are very appreciative of the assistance in the development of the youth in PNG for the past 5 years.

Women's Football

Women's football continues to grow with FIFA, OFC and PNGFA support with good results for the national women's teams.

FOOTBALL REPORT

Year 2014 started off with a big bang in February when the U20 women's team, lifted their game to finish second at the OFC U20 Women's Championship in Auckland, New Zealand which saw Meagan Gunemba receive the golden ball award. The 2-0 score line was the closest our ladies have come to a result in recent years.

PNGFA launched the FIFA U16 Meri Futbol competition in 2013 with the visit of the FIFA TV crew headed by Clement Chappat to film the development programs in place for women and girls. A second season has been underway with the finals in Goroka and Kimbe. New centres are proposed for 2015.

The Development Centres have been established in, Goroka, Wabag, Bougainville, Lahi, Wau, NBPOL, Madang and Port Moresby. Reporting has been the biggest hurdle and this area needs addressing in 2015.

Following an intensive training for the U15 YOG girls in Lae the selection panel under head of delegation for the YOG team, Nicola Demaine set out to put the best team possible for the Youth Olympic Games in Nanjing, China in September. The girls created history after they downed Namibia 3-2 in the 5th place play-off that enabled them to finish one rung higher than they did at their tournament debut four years ago in Singapore - their first win, their first goals and their highest finish.

Australian Gary Phillips was appointed Women's Head Coach in July, 2014. With the build-up towards the 2015 Pacific Games our women's team has been busy with their preparation starting off their campaign with the OFC Women's Nations Cup in Kokopo last month.

Their solid performance is a result of their intensive training in camp in Lae and the friendly matches in Brisbane and the Gold Coast in September.

Focus now turns to PG 2015 and the challenge to retain the gold medal. The support of the G4G Programme is most welcomed and appreciated. The opportunity for the girls to build on their strength and conditioning at the High Performance Centre in Boroko is a welcome addition to the quest for Gold.

**Men's National Team**

2014 saw the appointment of Oceania Player of the Century, Wynton Rufer as the men's National Coach. It was certainly a baptism of fire as PNG struggled to make its name felt when our U20 men's team battled it out in the

World Cup qualifiers in Fiji in May. After a moral boosting opening win against the Solomon Islands the team dropped away to finish 5th to Fiji, Vanuatu, New Caledonia and Solomon Islands.

Following a number of training camps throughout 2014 and a promising preparation camp and games in Australia the men covered themselves in pride in a close loss to Singapore in the island nation in September against their highly ranked hosts. In its second games in quick succession an experimental team then lost 5-0 to the Philippines in October. However, Rufer is positive about the future and is building a squad that he believes can challenge for honours at the PG 2015.

Youth Football in Papua New Guinea

The OFC Just Play programme, now in its 4th year, is very popular and will be rolled out to more areas in 2015 improving PNG children's lives through football with a commitment to – gender equality, improving school and classroom attendance, reducing the risk factor of non-communicable diseases and creating opportunities for children with a disability are a priority.

The programme has been extended beyond Port Moresby, to Lae, Kimbe, Madang, Bougainville - two centres, Simbu and Goroka. Ultimately it will go to other centres in 2015.

**Technical Development**

The support of FIFA and OFC has seen numerous courses held in PNG and in New Zealand, building human capacity and resource in coaching and refereeing for staff and members for the future development of the game. Grassroots to D and C licence courses have been conducted as well as refereeing and goalkeeping. The women's only coaching and refereeing courses have been groundbreaking and the first of its kind in PNG. The challenge is getting all of these trained human resources active and developing the game in the regions for the benefit of all.

Competitions

The Southern Region Besta Cup was hosted by Higaturu Oil Palm Soccer Association in Popondetta from 27-30 June. PMSA came out on top in both the men and women to take out the Southern Region title. The Besta Cup final was staged in Lae in October, without the defending champions Port Moresby Soccer Association (men and women), but saw three teams; Madang, Kimbe and Kainantu in the women's pool while Lae, Madang, Manus, Goroka and Higaturu competed in the men's division. Madang women and Manus men were crowned 2014 Besta FA Cup champions.

The Tablebirds Men's Under 17 and 19 championships were staged in Wau to assist in the talent identification of the players and also as the player pathway to become an International footballer. Madang U19 and LFA U17 took out the honours this year. The Tablebirds U18 Women were hosted by Madang and the hosts proved too strong for LFA completing a memorable double of men and women during an exciting tournament.

Soka Xtra

Following the launch of Soka Xtra in October 2011 the programme has grown from strength to strength with 134 shows now having gone to air. The weekly programme produced by the PNGFA media department under Leo Jackanduo continues to grow with exciting new items planned for 2015.

Papua New Guinea Netball Federation

Overview

2014 has been a challenging but an exciting year for the code. We have achieved a number of key milestones in the area of Governance and Administration and Game Development Programs.

Our High Performance Program continues to be a challenge but the Board is optimistic that with the investments that have been made in the team, we are optimistic for positive results in 2015.

Game Development

This has been the most successful program in 2014. PNG Netball has been able to implement our technical capacity building program in 10 associations out of the 15 that are currently affiliated to PNG Netball.

A total of 25+ umpires, a total of 12+ coaches and a total of 10 Bench Officials have been accredited this year under the PNG-Oceania Accreditation Framework.

Key milestones in this program this year has been the accreditation of PNG Netball BO Trainers and Assessors, Naomi Leka and Toka Aua as ONF accredited National Assessors and Trainers which is a high achievement for the code. Furthermore, Helen Lawrence has attained a dual accreditation as an ONF Accredited Umpire Coach and a Level 1 Accredited Coach which is a major achievement for Netball in PNG.

The capacity building program will continue in other centres in 2015.

Papua New Guinea Swimming Inc. (PNGSI) throughout 2014 continued to promote the sport of swimming through education and competitions and good governance. PNGSI had the unwavering support of all its executive members working together in a positive and committed manner to best serve our Clubs and their athletes, coaches and officials.

The 2014 Council Meeting and the Annual General Meeting of PNGSI was held on 24th March, 2014 which saw President, Elizabeth Wells MBE; Vice President, Bruce Mead; Treasurer, Sarenah Pini; Secretary, Carly Pini; Registrar, Barbara Skelton; Chief Technical Officer, Kathleen Maskelyne; Property Officer, Lois Nakmai; Public Relations, Margaret Gore and Honorary Auditor, Gore Accountants & Business Advisors elected.

In 2014 PNGSI was affiliated to FINA, Oceania Swimming Association and PNG Olympic Committee. Clubs affiliated to PNGSI were Lae Amateur Swimming Club and Boroko Amateur Swimming Club. Competitions held throughout the year have developed leadership, pride and team spirit in our athletes encouraging them to become the best they can be as we prepare for 2015 Pacific Games.

National events included:

TNT National Championships (Mar 21-23) a short course event which brought together our talented swimmers and volunteers from BASC and LASC to The Ela Murray International School to compete. 25 PNG Open and Age records were reset.

BASC Dolphin Sprints (Jun 6-7) was held in the National Capital of Port Moresby, a major annual event of BASC, where swimmers from Lae Amateur Swimming Club (LASC) and Boroko Amateur Swimming Club (BASC) came together to compete.

LASC Huon Gulf Championships (Aug 8-9) was held at the Coronation College 25m pool in Lae which saw two (2) PNG Age Records reset.

Theodist National Short Course Championships (Sept 19-21) was held in Port Moresby which saw 41 PNG Age, Open and Masters Records set. The competition provided an opportunity for our BASC and LASC swimmers to showcase their talent, swim personal best times and gain a place on the BSP National Kundu Aquatic Excellence Squads.

Major International competitions PNG swimmers participated in were:

Oceania Swimming Championships (May 20-23) was held in Auckland, New Zealand. 5 officials and 18 swimmers attended the event with many personal

best times swum and 15 PNG records taken and reset.

XX Commonwealth Games (Jul 23-Aug 3) was held in Glasgow, Scotland which saw 6 swimmers competing and 3 officials on the PNG Swim Team. Four PNG Records were recorded.

**2nd Summer**

Youth Olympic Games (Aug 17-22) held in Nanjing, China saw 12 days of high level competition and cultural and educational activities in place. PNG Swimming was represented by two swimmers, one male and one female swimmer and a coach.

12th FINA World Championships (25m) (Dec 3-7) held in Doha, Qatar saw 10 swimmers and 5 officials taking part. The results showed great improvement across the board with 18 individual PNG Age and Open Records swum along with 7 Open PNG Relay Records, a total of 25 PNG Records were recorded.

At the close of the year in competition we had a record number of swimmers being awarded a position on the PNG Train on Squad for Pacific Games and the BSP National Aquatic Excellence Squads. These squads continue to provide an incentive and motivation for our swimmers to do well and achieve. A record number of PNG Records were challenged and broken throughout 2014 in all competitions attended as personal best times were swum.

Areas of education both in country and overseas explored in 2014 were:

Dream Program hosted by Gangwon Province of Korea (Jan 13-25) in the city of Pyong Chang provided a truly unique opportunity for PNG swimmers, Sheldon Plummer and Ashton Kunda; and Coach, Lambert Vure to participate in a winter sporting program providing them with a better understanding of the Winter Olympics and winter sports. The opportunity was accorded by PNGOC.



ASCTA Coaches Convention (May 1-4) was held at the Sofitel, Broadbeach on the Gold Coast with four PNG Coaches, Lambert Vure and Albert Vigil from Lae Club and Susan Babao and Villiwa Puana from Boroko Club attending. International Bronze License accreditation from ASCTA was awarded to Joe Meaurio, Villiwa Puana and Albert Vigil in 2014.

Runaway Bay Sports Centre Swim Camp (Apr 3-9) was held on the Gold Coast, Queensland where 25 members of PNG Swimming attended a five-day elite in-depth/intense swim camp. All came back with a better understanding of the importance of setting goals for individual progress and communicating positively with team members helping each other along the road to gain successful outcomes. A great mentoring experience was also had by the coaches who appreciated the guidance of the three elite coaches in attendance during the camp.

FINA World Swimming Officials Seminar (Jun 20-21) was held by FINA in cooperation with USA Swimming in Miami, Florida which saw PNG FINA Referees Susan Babao and Sarenah Pini attend.

2014 Technical Officials Clinic (Sept 18-21) was held prior to and in conjunction with the Theodist National Championships in Port Moresby. The Clinic was opened by Hon. Minister of Sport and Pacific Games, Mr. Justin Tkatchenko, who emphasized the importance of providing competent and skilled Technical Officials during our hosting of the Pacific Games 2015. The course program consisted of a theory component from the 18-19 September and a practical component from the afternoon of the 19th through to 21st September in conjunction with the Theodist National Championships.

Together with the funding made available through the PNG Olympic Committee (G4G) funding and BSP sponsorship and our tireless band of volunteers, we continue to provide the support to strengthen our communities through youth development, healthy living and social responsibility, establishing a positive, productive direction for the code of swimming to travel on.
