

President's Message

Good Morning Member National Federations and invited Stakeholders and Partners.

Thank you for your attendance today at the Papua New Guinea Olympic Committee's 2018 Annual General Assembly.

As our members, PNGOC recognizes the importance of ensuring you are kept informed and involved in the governance of our organisation.

I want to assure you that the PNGOC Board does its utmost best to ensure that decisions made will positively impact you our members, sport in PNG and Team PNG.

The board remained active and engaged throughout 2017, conducting 6 Executive meetings as required under our constitution. I am pleased to say that we have an extremely robust board with a commitment to ensuring strategic and key decisions are made for the smooth implementation of strategic directives by Management.

The board continues to work with management in our shared aim to excel in corporate governance with oversight and guidance in the continued delivery of our strategy.

The following is an extract from Australian Sports Commission Sports Governance Principles:

"Governance is the system by which organisations are directed and managed. It influences how the objectives of the organisations are set and achieved, spells out the rules and procedures for making organizational decisions and determines the means of optimizing and monitoring performance including how risk is monitored and assessed.

Effective sports governance requires leadership, integrity and good judgment. Additionally, effective governance will ensure more effective decision-making, with the organization demonstrating transparency, accountability and responsibility in the activities undertaken and resources expended".

We do our best to provide effective leadership with the support of respective Committees to promote the success of PNGOC for benefit of our members and Team PNG.

PNGOC in the last two years has focused on improving its governance standards with adoption of the new constitution and policies to strengthen the organization.

With the increased numbers of participation in sport, more elite athletes and more funding invested in sports, there has seen more interest in sports and how they are governed.

There is also greater interest by stakeholders of sports including athletes who want to have their views heard and reflected appropriately in decisions of sporting bodies. Our two Athletes Commission members on the Executive ensure that we are kept up to date with relevant issues which are covered in their reports at all board meetings.

The autonomy of sports organisations is a basic principle of the Olympic Movement and is something the PNGOC will strongly advocate for. But in order to justify our continued autonomy, there is an even greater responsibility for sport to operate with integrity.

The integrity of sport has been subject to significant challenge over recent years globally and nationally and therefore it is increasingly more important for us as administrators and leaders of our sports to work on improving and strengthening our governance and administration.

We are all challenged to adhere to our constitution as best practice.

We have an excellent program in the region, the Oceania Sports Education Program with different levels of courses of sports administration and management offered every year. Lets be a little proactive and bring these courses to our membership for clubs, provincial and executive members that require up-skilling. This is one program that PNGOC is offering to enhance capacity of National Federations.

t is with a sense of satisfaction that we can look back on a year that has in many respects been challenging, but positive. 2017 was indeed an eventful year with Team PNG's participation in three games.

Preparing and ensuring the participation of Team PNG in the Commonwealth Youth Games; the Asian Indoor and Martial Arts Games; and the Pacific Mini Games all in the same year was a task in itself. This included meeting critical deadlines of GOLDOC for the 2018 Gold Coast Commonwealth Games in the last quarter of 2017.

Reaching new heights



2017 has seen the Papua New Guinea Olympic Committee (PNGOC) reach new heights as we ventured into new beginnings and partnerships in the first year of the new Olympic Cycle.

Amongst the new beginnings included Team PNG's participation at the 5th version of the Asian Indoor & Martial Arts Games (AIMAG) as well as the addition of several new corporate partners.



The annual events reached new heights as the organization looked to build on the foundation that was set in 2016 with its new strategy and direction.

Celebrating 25 years of the SP Sports Awards reflecting the partnership between SP Brewery, PNGOC and PNG Sports Foundation, the 2017 SP Sports Awards saw more than 60 nominations received from around the country to recognize the efforts and achievements of athletes, officials, administrators, volunteers, journalists and programs from the 2016 calendar year. Nominations for this year's awards covered a wide range of sporting codes including, Rugby League, Weightlifting, Cricket, Tennis, Basketball, Swimming, Athletics, Football, Karate and Para-Sport.



Guest speaker at the presentation was Australian Rugby League legend, Wally Lewis. The Rugby League immortal shared some insight into his illustrious career with the Brisbane Broncos, Queensland Maroons and the Australian Kangaroos and presented the major awards to the winners.

TRUKAI FUN RUN DRAWS MANY

The 2017 Trukai Fun Run witnessed over 50,000 enthusiastic participants took to the streets around the country, which included over 30,000 participants alone attending the event in Port Moresby. A sea of yellow flowed through the 5km route in Port Moresby as people took to the roads in the early hours of the morning.

The shirts were sold during auctions in Lae and Port Moresby and in retail outlets. Funds raised went towards Team PNG's preparations and participation at the Pacific Mini Games in Vanuatu.

Thirty teams representing various organizations came together to battle it out on the greens for the 2017 Team PNG Prime Minister's Corporate Golf Challenge held in Port Moresby.

With support from The National the event was a success, with funds raised going towards helping to send Team PNG to the Pacific Mini Games in Vanuatu, Commonwealth Games in Gold Coast and Youth Olympic Games in Buenos Aires.

The Olympic Day celebrated on the 23rd of June world-wide was another fantastic opportunity for Team PNG athletes to not only promote the Olympic Movement and the Olympic Day Pillars of Move, Learn & Discover, but to also inspire and educate students from various schools with a week of activities.

Fittingly the Queen's Baton was taken to the Kimbe where it was greeted by the people of West New Britain Province as well as athletes from all over the country as it featured in the closing ceremony of the 6th PNG Games.

There were some notable achievements and appointments with PNGOC President, Sir John Dawanincura the most notable of them all when he was honored by the Association of National Olympic Committees (ANOC) with the Merit Award, during ANOC's XXII Annual General Assembly in Prague, Czech Republic in November 2017.

Sir John was recognized for his outstanding service to sport and the Olympic Movement spanning over 45 years of which 30 of those being with the PNG Olympic Committee.

This year 15 more athletes underwent the HERO training to become Team PNG HERO athletes and took part in various events and program activities throughout the year including the NCD School's Cervical Cancer Vaccination program and Young Port Moresby Chamber of Commerce gatherings.

The IBS University backed athlete scholarship Athlete Excellence Program saw eight athletes receive free education from the tertiary institution. It was fantastic to hear during the graduation at the end of the year that three athletes were recognized as the top three IT students, with Charles Amini Jr. receiving the top student award.

FIVE MOSO PARTICIPANTS GRADUATE

The highlight of the year saw five participants graduate in the first ever nationally run Advanced Sport Management Course of the Managing Olympic Sports Organizations (MOSO) program in the Pacific. The MOSO program was held over six weekends with six modules covered.

All participants completed their course by delivering a presentation on one case study they had written on their individual national sports federation. Swimming's President, Elizabeth Wells was awarded the MOSO Best Student Award.

The very first tracer study audit was also completed with OSEP administrators completing the tracer study to gain feedback on the courses run in the country so far. The feedback will be used to strengthen the delivery of the program and improve on outcomes.



At the end of the year PNGOC had signed a tripartite OSEP MoU for PNG with ONOC/OSEP Regional and the Government's PNG Sports Foundation. The MoU will guide the work of the three organisations in delivering OSEP courses in PNG.

It was a busy year for Team PNG with our athletes and officials travelled to three international Games over the course of 2017.

TEAM PNG IN THE BAHAMAS

Team PNG touched down in the Bahamas in July for the Commonwealth Youth Games with a team of 16 Athletes and Officials. Four sports were in action, which included Swimming, Tennis, Beach Volleyball and Athletics.

Michael Henao was the Chef de Mission with Tennis' rising star, Mathew Stubbings given the honour of carrying the PNG flag at the opening ceremony. Several personal bests were broken with these young athletes gaining valuable competition and Games experience that will see them represent Team PNG and future games.

It was an historical moment as Team PNG joined other Oceania nations to compete at the Asian Indoor & Martial Arts Games (AIMAG) for the very first time at the invitation of the Olympic Council of Asia. Hosted in Ashgabat, Turkmenistan, the Games had 21 sports contested across fifteen competition ON THE BALL: Moses Lune Apiko with the venues from ball in PNG's Men's 3x3 September Basketball team at the 17th to 27th. A total of approximately six thousand athletes and officials were in attendance across 65 countries – 45 from OCA, 19 from Oceania and the African refugee team.

Team PNG was there with a contingent of 17 which included 9 athletes, 4 sports officials and 4 General Management Team. PNGOC President Sir John Dawanincura had attended as an invited guest with Michael Henao leading the team once again as the Chef de Mission.

There were no medals won but a lot of experience was gained from competing at this level. Several personal bests were recorded throughout the 14 day campaign.

TEAM PNG AT THE PACIFIC MINI GAMES

To end the year, we sent Team PNG made up of 89 Athletes and 46 Officials to the Vanuatu 2017 Pacific Mini-Games.

Chef de Mission, Emma Waiwai led the 135 strong Team PNG contingent where they competed in 10 of the 14 sports on the program including Athletics (including Para), Basketball (3x3), Beach Volleyball, Boxing, Golf, Karate, Netball, Table Tennis, Tennis & Weightlifting.

Team PNG finished with 33 Gold, 31 Silver and 24 Bronze to finish second behind New Caledonia but had won the most medals at the Pacific Mini-Games.

Weightlifting brought home 14 Gold Medals, Athletics brought in 17 Gold with Beach Volleyball Men and Net-

ball the other two sports contributing to the gold medal tally.

The Mini-Games provided a sound platform for our athletes to focus towards their next Games targets whether that may be the 2018 Commonwealth Games in Gold Coast or the 2019 Pacific Games in Samoa.

Support for Team PNG and PNGOC from our corporate partners played a big role in sending Team PNG away to these three Games and is always massively appreciated. It was extremely pleasing to have our family of partners grow with first time sponsors, Kumul Petroleum Holdings Limited come on board as a Platinum sponsor with funding to support Team PNG to the Pacific Mini-Games and Gold Coast Commonwealth Games, and Capital Insurance sign an agreement to cover Team PNG until 2020.

The continued support from Trukai Industries, Air Niugini, PNG LNG ExxonMobil, SP Brewery, The National, Coral Seas Hotels, IBS University, Theodist, Nambawan Trophy, Blue7Team and Media Partners was immense.

ANNUAL GENERAL ASSEMBLY 2017

The Annual General Assembly for 2017 saw the Board and the Secretariat present the audited financials to the members, the National Federations. The program also saw the graduates of the MOSO program present their case study to the member federations.

Funding support was provided to assist the sports and their athletes and coaches with activities in line with the preparation plans for upcoming Games. PNGOC also assisted the PNG Powerlifting Federation with their Annual General Meeting and PNG Volleyball Federation with the finalization of their Strategic Plan.

Five athletes were confirmed as recipients of the Olympic Solidarity Tokyo 2020 Scholarships in 2017. This funding will assist Dika Toua and Morea Baru of Weightlifting, Toea Wisil and Rellie Kaputin of Athletics and Sam Seghers of Swimming to pursue their Olympic dreams to qualify and compete in Tokyo 2020.

2018 will be another big year for PNGOC with two international events in its sporting calendar. These are the Commonwealth Games in Gold Coast, Australia from April 4 to 15 and the Youth Olympic Games which will be held in Buenos Aires, Argentina from October 6–18.



PNGOC welcomes the opportunity to collaborate with all of our members, partners and stakeholders in 2018.

We recognize the commitment of our member National Sporting Federations to developing sport in PNG and contributing to the success of Team PNG through the work they do.

Our sponsors and partners have supported us throughout the year and we are indebted to their generosity.

Primary role and functions of the Athletes Commission

The Papua New Guinea Athletes Commission is established as a committee by Papua New Guinea Olympic Committee Inc (PNGOC) as required by the International Olympic Committee.


The primary role of the PNGAC is to represent and advocate for the welfare and best interests of all Team PNG elite athletes. Elite athletes are defined as those athletes that comprise the final training squad (and final team) of any sport that participates in the Mini-Pacific Games, Pacific Games, Commonwealth Youth Games, Commonwealth Games, Asian Indoor Martial Arts Games, World Beach Games, Youth Olympic Games and Olympic Games.

To this end, the chair and deputy chair of the PNGAC sit on the PNGOC Board as athlete representatives. We also have a member of the PNGAC sit on each sub-committee of the PNGOC, including the Justification Committee but excluding the Administration Committee.

We are aware that many elite athletes and National Federations are still aware of the role of the PNGAC and how the PNGAC can assist to address elite athlete issues. We have therefore been on a conscious drive to lift and enhance the profile of the PNGAC by partnering with other stakeholders and extending our reach through organically building additional capacity.

Our primary role gets triggered mostly around Team PNG and we are usually busy with selection and appeal matters during respective multi-sport Games.

AC Meetings

The Athletes Commission met six times to ensure that its primary role is carried out and maintained through its regular meetings.

Athletes Welfare & Issues

In the effort to address welfare and interest of elite athletes, the AC has closely looked at these issues and provided assistance where possible. In 2017, the AC had to deal with issues from 5 sports. Issues ranging from administration, disciplinary, duty of care, well-being and medical.

- Governance incorporation of PNG Medical Commission, PNG Volleyball & PNG Basketball; Drafting of Constitutions 5 SOs; recommended wording for athlete rep in NF structure
- **Disciplinary matter** Cricket PNG Disciplinary Tribunal
- NF Administration Cricket, Weightlifting, Para-sports
- Athlete welfare employment advice; accommodation issue;
- The Bridge i.e. being an intermediary Athletics PNG

TEAM PNG SDG Champions with UN PNG

The partnership between the United Nations and PNG Olympic Committee was launched on the 23rd of June coinciding with the Olympic Day celebrations at the Rita Flynn courts which saw five (5) TEAM PNG athletes announced as SDG Champions.

Four members of the commission and one from the Gender Equity Commission (GEC) underwent a one-day training organized by UN to learn about the SDGs, advocacy of the SDGs and the implementation plans in alignment to the National priorities. The four members of the AC who are now SDG Champions are Ryan Pini, Lua Rikis, Chris Amini and Milton Kisapai. Lua and Milton have also graduated with their degrees from the University of Papua New Guinea and are both fine examples of dual career athletes.

AC MEMBERS AND ATHLETES EDUCATION

Oceania Sports Education Programme (OSEP)

The Athletes Commission continue to encourage its members to be actively involve and participate in the Oceania Sports Education Programme. The OSEP courses are seen as a great opportunity for capacity building for in preparation for life after sport.

Three AC members Chris Amini, Lua Rikis & Linda Pulsan under took Presenter & Assessor training.

TEAM PNG HERO Training

The Athletes Commission in its efforts and commitment to TEAM PNG athletes, continues to support the TEAM PNG HERO Programme by ensuring Team PNG athletes attend and gain all necessary training to help build their abilities to be better role models in the community.

 Chris Amini of AC was also part of this year's program which ran from 15th -19th May at the IBS University, 6mile campus.

Oceania Regional Anti-Doping Organisation (ORADO) Educator Training

Anti-doping knowledge and awareness has always been a top of the table agenda and priority for the AC. The course ran from the 25th -26th May at the Sir John Guise Stadium. On the 27th the trained educators delivered the anti-doping session to athletes. Again an open invitation was sent to athletes to apply if interested to take up the course. Two (2) AC Members – Milton Kisapai and Chris Amini successfully completed the Educator Training. Linda Pulsan and Francis Kompaon attended the anti-doping session as participants.



Executive Masters in Sports Organisation Management

• AC Chair Karo Lelai successfully completed and graduated from her MEMOS program. She drafted a model constitution for National Federations that complies with PNGOC, IOC and WADA requirements

Athlete Career Pathway

Ryan Pini was invited to represent Oceania at the Athlete Career Program forum where he was given an opportunity to speak on athlete transition and athlete engagement. He has asked for representation at the next forum to present our program – TEAM PNG HERO Program.

PNG Institute of Directors Training

Three AC members Chris Amini, Nellie Tetaga & Milton Kisapai attended a two days Director Program at the PNG Institute of Directors. These sort of training sessions are part of our Excellence 4 Life initiatives and also capacity building/succession planning vis-a-vis the next generation of leaders in sports. In the coming year, other AC members have opportunity to do the program.

Olympic Values Education Program

AC members Linda, Milton and Chris have continued with running OVEP sessions with other TEAM PNG HERO athletes at schools and communities around PNG through funding from Exxon Mobil. OVEP has been to Daru, Kokopo, Hiri West, Lae, Mt. Hagen, Mendi and Kimbe in 2017.

Milton Kisapai, Linda Pulsan and Chris Amini with another TEAM PNG HERO athlete (Jacklyn Lahari) took part in the Youth Arts Program hosted at the Moresby Arts Theatre on the 13th & 14th and from the 17th – 19th July promoting the main stream messaging of the Sport and Environment Program.

Games

Chris Amini was privileged to be General Manager of TEAM PNG to Ashgabat, Turkmenistan from 13th -30th September for the Asian Indoor Martial arts Games (AIMAG).

Milton Kisapai was appointed as the Athletes Rep to the 2017 Pacific Mini Games in Vanuatu.

Opinion

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Papua New Guinea Olympic Committee Inc. is an association domiciled in Papua New Guinea. The address of the associations' registered office is at Sir John Guise Stadium Port Moresby, National Capital District Papua New Guinea. The association's principal activity is a non-government organization that represents the interests of its members, the National Sports Federations.

The Papua New Guinea Olympic Committee Inc. includes the National Olympic Committee, The Commonwealth Games Association, The Pacific Games Association, and the Fund Raising Committee.

The financial statements were approved at the Executive Committee Members Meeting held on the 26th June 2018.

(a) Subsidiary

The Papua New Guinea Olympic Committee Inc. owns 100% of the PNG 2015 Pacific Games Organising Committee, PNG 2015 Pacific Games Ltd. The investment in subsidiary is shown at nominal value representing value of share capital subscription.

(b) Basis of preparation

The financial statements have been prepared in accordance with the accounting policies as determined by the Association's executive committee that is consistent with the requirements of the Associations Incorporation Act and the financial reporting requirements as per the Association's constitution. The financial statements have been prepared on a historical cost basis applying the accrual accounting concept.

Special purpose financial statements

This is a special purpose financial report for the sole purpose of providing financial information to the members and must not be used for any other purpose.

The association is an exempt organization in accordance with Section 171 of the Companies Act 1997 as the members have elected to be exempt under Section 171 (1b).

(i) Presentation of financial statements

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, and have been applied consistently by the Association.

(ii) Foreign currency transactions

Transactions in foreign currencies are recorded at the exchange rate at the date of the transaction. Foreign currency monetary assets and liabilities are translated at the exchange rate at the balance date. Resulting exchange differences are recognised in the profit and loss account for the year. Non-monetary assets and liabilities denominated in foreign currency are recorded at the exchange rate at the date of the transaction.

(iii) Property, plant and equipment

Items of property, plant and equipment are stated at original cost less accumulated depreciation and impairment losses.

Depreciation is provided on cost amount of all fixed assets, including buildings so as to write off the assets progressively over their estimated useful lives. Fixed assets are first depreciated in the year of acquisition.

(iii) Property, plant and equipment (continued)

The straight line method of depreciation is used and the rates of depreciation used are:

Office equipment 30%
Motor vehicles 25%
Furniture and equipment 12.5%
Buildings 4%

(iv) Impairment

The carrying amounts of all assets are reviewed at each balance date to determine whether there is any indication of impairment.

(v) Inventories

Sports wear and accessories purchased for past Olympic, Commonwealth and Pacific Games, but not yet used are valued at the lower of cost and net realisable value.

(vi) Provisions

Provisions are recognised when the association has a legal or constructive obligation as a result of a past ev and it is probable that an outflow of economic benefits will be required to settle the obligation.

(vii) Taxation

The association is exempt from income tax under Section 27(b) of the PNG Income Tax Act as a sporting box

(viii) Revenue

The major source of revenue for the association is grants and sponsorship income. Revenue is recognised w the funds are received.

(ix) Provisional Reserve

The association allocates grants and sponsorship income to individual projects. The excess of such allocation income over expenditure are transferred from the Statement of comprehensive income into a "Provisic Reserve" and included as "Funds held in Trust" in the Statement of financial position.
