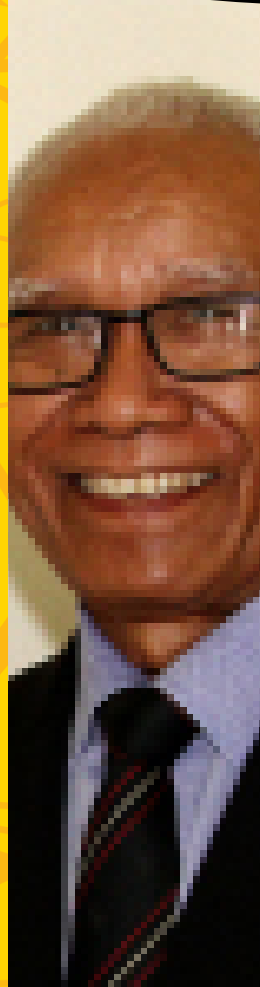

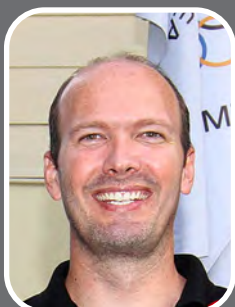

A Pacific Games year is always a mammoth year in the PNGOC calendar of events. Samoa indeed was a spectacle that had so many expectations and thrills.

One of the more striking demonstrations of our efforts and resilience was displayed in week two of the Pacific Games. Having witnessed the trough of emotions from organisation, execution and participation, and culminating in the creation of history by having Team PNG win its most ever medals on foreign soil at the Samoa 2019 Pacific Games, I am excited about what the future holds for Team PNG.

A special mention goes out to the female athletes who took home 67% of the gold won at the games by Team PNG. You have done your country proud and ultimately inspired the next generation of female athletes. Again, I reiterate, these are changing times.

Our very own Sprint Queen Toea Wisil should be proud of her efforts as we are of her. Toea won four (4) golds and one (1) silver, and in the process completed a historic games triple by winning the 100m, 200m and 400m for the third successive Pacific Games.

To our 2019 Pacific Games flagbearer, Abigail Tere-Apisah, leading from the front, you did your sport, Team PNG and Country proud with your dominance on the court resulting in three (3) gold and one (1) silver medal. I take this opportunity to Congratulate Emma Waiwai, Team PNG Chef de Mission for 2019 Pacific Games, and her Management Team for their tireless efforts in assisting to achieve an outstanding outcome. And for that matter I also congratulate all the Athletes and Team Officials for their contribution in our Success in Samoa.

Every day we have been networking and leveraging our members, volunteers, partners and stakeholders, culture and resources to address the challenges facing our organisation and community. We continue to plan for the future through new initiatives such as the Athlete Friendly Company, Sustainable Practices, Athlete Scholarships, Resource expansion for the resource centre and the NF Hub. 2019 was an exceptional year for the Papua New Guinea Olympic Committee (PNGOC) with significant moments spread throughout the calendar. Our dream of having our own permanent home was fully realised with the official opening of the PNG Olympic Haus by the International Olympic Committee (IOC) President Thomas Bach.

Team PNG attended the 2019 Pacific Games in Samoa, with our motto being One Team One Dream. The motto aptly portrayed the unity of purpose for Team PNG.

The same unity of purpose was evident in everything the PNGOC did in 2019 to achieve our goals and work towards our vision of inspiring and uniting Papua New Guineans through sporting excellence and success.

ACTIVITIES IN 2019

The work of the PNGOC is guided by our strategic plan and focused under the plan's five key result areas (KRAs). The first of those KRAs is to work towards being the best performing NOC in the Pacific with a focus in 2019 on governance, management, resource mobilization and knowledge capture.

The most significant development for the PNGOC in 2019 was the realization of a long held dream to acquire our own office property when IOC President Thomas Bach opened the new PNG Olympic Haus in May. The PNG Olympic Haus now provides a lasting base for the PNGOC to sustainably operate and grow from and provide the services and facilities needed to support our members.

The PNGOC Annual General Assembly was held in June where our unqualified audited financial reports were presented to and accepted by the membership. The member national federations agreed to a change of our constitution to reflect the responsible use of performance reserve funding into the future. The

members also unanimously agreed to Fencing Papua New Guinea becoming our fortieth national federation member.

The Secretariat provided support to the work of the PNG Athletes Commission (PNGAC). In the lead up to the 2019 Pacific Games, the PNGAC was committed to ensuring the athlete voice was heard in the justification process of athletes and officials to Team PNG for the Games. The PNGAC was on also hand to provide advice and guidance for athletes who appealed against non-selection, as well as raising issues that were related to athlete welfare and safeguarding.

Lua Rikis and Milton Kisapai were present at the

Pacific Games in Samoa as Athlete Representatives for Team PNG and witnessed the election of the new members to the PNGAC. The members of the new PNGAC who will serve their four year term until the 2023 Pacific Games are Chairperson Ryan Pini (Swimming), Deputy Chairperson Lua Rikis (Netball), Milton Kisapai (Hockey), Judith Meaurio (Judith Meaurio), Nigel Bana (Karate), Lorraine Harry (Weightlifting), Toua Udia (Weightlifting), Lois Garena (Volleyball), Vagi Henry (Powerlifting) and Raphaella Baki (Boxing).

The PNGOC recognizes the efforts of the outgoing PNGAC members who completed their term in 2019, Chris Amini, Nellie Tetaga, Linda Pulsan, Moha Mea, Kapu Kapi and Nelson Stone. Outgoing Chairperson Karo Lelai remains a member as part of the new PNGAC due to her position as ONOC AC Chairperson.

By virtue of their positions as Athletes Commission's Chairperson and Deputy Chairperson respectively, Ryan Pini and Lua Rikis became new members of the PNGOC Executive Board this year. Their appointments maintained the 3:2 ratio of female to male board members on our Executive.

The ten new AC members were assigned to the various PNGOC committees to ensure the athletes' view is represented.

In line with their goal to raise awareness and generate discussion on gender issues at all levels of sport, the Gender Equity Committee delivered a session to a rural community in Hula village with community sports volunteers and teachers. Similar sessions will be delivered in the other regions of PNG in 2020.

PNGOC recognizes the importance of ensuring the wellbeing of our athletes. This year the Executive Board adopted the NOC's Athlete Safeguarding Policy, which provides clarity to NOC staff, volunteers and our members NFs on the definitions of harassment and abuse and lucidity on how related issues will be managed by PNGOC with an emphasis on education in this important area.

In our efforts to modernize our business practices, the PNGOC completed the switch to Microsoft 365

as our operating software. The switch has allowed the secretariat to strengthen our data management and archiving capabilities and has provided new internal and external communication options to help make our work more efficient and effective.

Raising the funds needed to cover the Games budget for Team PNG to the 2019 Pacific Games was an immense task. A big part of raising funds was through our two major fundraising events, the Trukai Fun Run and the Prime Minister's Corporate Golf events.

The Trukai Fun Run celebrated 20 years of Trukai sponsorship by successfully staging the event in centers through PNG including Port Moresby, Lae, Ramu, Madang, Kokopo, Alotau and Goroka. The route in Port Moresby saw participants enjoy Ela Beach and Fairfax Harbour views as they ran from the Paga Hill Ring Road to the Sir Hubert Murray Stadium and back.

To commemorate the twenty year milestone rugby league legends from the North Queensland Cowboys Jonathon Thurston and Brent Tate added some star power to the Trukai Fun Run shirt auctions held in Port Moresby and Lae and helped to see over 96,000 fun shirts sold. The success of the event is reliant on the hardworking staff of Trukai and the great support received from stakeholders including the Royal PNG Constabulary, PNG Defence Force, Correctional Services St Johns,

With the support of The National newspaper, the Prime Minister's Corporate Golf Challenges in Lae and Port Moresby saw a total of 48 organizations playing for the Team PNG cause. It was great to see the challenge return to Lae after a couple of years of absence with Comsat Goroka winning the top prize. The team from Bank of PNG took home the spoils from the Port Moresby challenge.

Recognising our sporting heroes is an important part of inspiring others and the 2019 SP Sports Awards once again provided the opportunity to acknowledge the fantastic efforts of the special individuals who make sport in PNG. Six Team PNG members were finalists in the various award categories of the 2019 awards with Steven Kari and Dika Toua taking out the Athlete of the

year awards in both Male and Female categories. Guest Speaker and gold medal Olympian, Australian Beach Volleyball athlete Kerri Pottharst shared with the audience at the presentation night stories of her career and the secrets of her success.

There was a special announcement of the introduction of a new award, the Stan Joyce Award, as acknowledgement of the fantastic support the outgoing SP Brewery Managing Director has provided. The award will recognise individuals and organisations that have provided significant support to sport in PNG.

We also recognised those special PNG sporting icons whose achievements have elevated our nation, through our fifth PNG Sports Hall of Fame induction ceremony. PNG's most dominant athletics athlete and Olympian Iammo Launa, multi-Pacific Games gold medalist and

weightlifter Sibona Oka and Commonwealth Games gold medalist in lawn bowls Geua Tau were inducted into the Hall of Fame in November.

Learning and professional development is key to the development of our NOC. In 2019 we were proud to see PNGOC's Performance Coordinator Chris Amini become the first participant from PNG to complete the International Coaching Enrichment Certificate Program. His project focused on developing an elite level course to build the capacity of Team PNG coaches. Sports Education Coordinator Alurigo Ravusiro has embarked on her MEMOS journey, which will see her work on a project focused on exploring the benefits to national federations from sports diplomacy. Games Coordinator Asiani Vagi benefited from her involvement in the ORADO anti-doping curriculum development team, which also allowed her to spend some time with the New Zealand Olympic Committee learning from their games management practices.

Team PNG Games Success is the second of our KRAs. A Pacific Games year is always one that provides an increased workload for the NOC, from resource mobilization to Games preparation and management. The Pacific Games always signify the biggest of Games for Team PNG in terms of team size and participation and the Samoa 2019 Pacific Games saw Team PNG compete in 26 sports on the program with 473 athletes and officials experiencing the magic of the Pacific Games and the warm

hospitality of the Samoan people.

Team PNG created history in Samoa by winning our most ever medals on foreign soil and in the process finishing second on the medal tally with 39 gold and 131 overall medals. Our female athletes once again outperformed their male counterparts by winning 29 gold medals, or 67% of the gold won by Team PNG.

Athletics with 14 gold medals, weightlifting with 8 gold, powerlifting with 6 gold and boxing, tennis and touch with 3 gold medals each were the sports who contributed the most to our medal tally. Special mention is given to touch for winning all 3 gold medals on offer for their sport and our women's football team who defended their gold medal for the fifth Pacific Games in a row. We were also extremely proud of the efforts of Toea Wisil who won 4 gold medals and one silver, in the process completing a historic Games triple-triple by winning the 100m, 200m and 400m for the 3rd Pacific Games in a row. Toea was recognized for her Pacific Games exploits when she was awarded the ANOC award for best Oceania female athlete at the Pacific Games.

Team PNG Flagbearer for the Samoa Pacific Games, Abigail Tere-Apisah was another standout performer. Abigail's dominance on the tennis courts in Apia saw her win 3 gold medals and a silver medal.

The PNGOC together with athletes, coaches and executives from the sports analyzed our performances from the 2019 Pacific Games at a Games Evaluation

workshop held in August. Team PNG's Chef de Mission to Samoa, Emma Waiwai shared her thoughts on the Games feedback received from athletes and officials. The workshop provided the opportunity to reflect and evaluate aspects of performance that can be improved for future Games. It also allowed for sports to give feedback to the PNGOC on our team selection and justification process and the services provided to sports as part of preparation for the Games and during the Games. The increased emphasis on medical and physiotherapy support was acknowledged by sports.

Focus in 2019 was also on the Tokyo 2020 Olympic Games and ensuring all requirements were attended to. Chef de Mission Tamzin Wardley's participation at the Chef de Mission seminar and Olympic Solidarity 2019 Oceania Forum provided additional information needed to ensure the NOC's planning and preparation for the Games is at the standard expected for our athletes to have an exceptional Games experience.

Tokyo 2020 Olympic Solidarity scholarship holders, Dika Toua, Morea Baru, Sam Seghers, Toea Wisil and Rellie Kaputin continued to benefit from the funding support as they worked towards their Olympic qualification dreams.

The PNGOC's work is made possible through the partnerships we

share with our stakeholders. Ensuring that we maintain active, complimentary and value-adding partnerships with our key stakeholders is the focus of our third KRA. In 2019 our partnership with Government was enhanced through the signing of a MOU with the PNG Sports Foundation, which was witnessed by the IOC President and the Prime Minister of Papua New Guinea. The MOU clarifies areas of cooperation between both organizations and will strengthen our working relationship.

This year also saw PNGOC involved in the process of reviewing and drafting the National Sports Policy. Lead by the PNG Sports Foundation, the process is close to its end and the Policy should be launched in early 2020. The policy will provide guidance to sport implementers for the next 30 years under the theme of securing the nation's future through integrated sport development and sport for sustainable human development.

We value the support we receive from the IOC, ONOC and the Commonwealth and Pacific Games movements we are a part of. We also strive to ensure we value add to these movements through our representation on their various committees and involvement in various initiatives. We congratulate our new Athletes Commission Chairperson Ryan Pini for being re-elected to the role of Pacific Games Council Athletes Representative at the Samoa Pacific Games. Ryan was also confirmed this year by the IOC as one of 30 candidates up for election to the IOC Athletes Commission with voting to take place at the Tokyo 2020 Olympic Games.

Fellow PNG Athletes Commission member and NOC Programs Coordinator Milton Kisapai assisted the Guam Athletes Commission develop their Olympic Values Education Program (OVEP) when he travelled to Guam in November to facilitate an OVEP training session.

Milton was also recognized for his commitment to promote the Sustainable Development Goals (SDGs) when he was invited to represent PNG at the UNESCO sponsored Asia/Pacific SDGs and Sport funshop in Korea.

The NOC welcomed our new Corporate Manager, Ian Leklek to the role in early 2019. Ian has prioritized our efforts to develop commercial activation strategies with our sponsors and maintain the value they receive from their support of Team PNG.

The PNGOC will continue to look for opportunities to expand our stakeholder network and bring value to our existing partnerships.

PNGOC understands the vital role National Federations play in the delivery of sport in the country and the unique and often trying circumstances they face. Enhancing the capability of our National Federations is our fourth KRA. 2019 saw considerable focus on working with NFs to improve their governance. Through the efforts of our Governance and Compliance Officer, Desmond Kaviagu, an effective

governance and compliance tracking system is in place which monitors the status of each NF in relation to the key membership requirements of the NOC. Support was also provided to assist NFs with the process of becoming a recognized incorporated association under Government law.

An exciting development in 2019 has been the launching of the NF Hub. The NF Hub provides a free, user-friendly and simple web-based solution to many key issues affecting NFs. Powered by Microsoft Office SharePoint Online, the NF Hub is a PNGOC communication site accessible to each NF. Each NF also has their own site on NF Hub to upload key documents, latest news and events, general information on their sport and securely store information online. One-on-one sessions with NFs were held in November and

December to introduce the NF Hub to our sports, take them through key governance areas and provide them with the opportunity to raise important issues with the PNGOC.

The delivery of Oceania Sports Education Program courses has been our main approach to enhancing the capability of NFs. There were 17 OSEP training courses delivered in 2019 with 284 participants certified. Included in the courses delivered were the OSEP Team Managers course and OSEP Strength and Conditioning courses delivered for the first times in PNG. The courses targeted Team PNG selected officials in a concerted effort to develop the capacity of the key members of our athletes' entourages. The NOC has also promoted the "Building Better Management" OSEP online learning course with NFs as a means to improve their

sports management capacity.

As recognized by all, athletes are at the heart of the sporting movement. The PNGOC’s fifth KRA focuses on providing athletes with opportunities to inspire others and pursue their own ambitions.

Every year our activities linked to Olympic Day on June 23rd provide an opportunity for PNGOC and our HERO athletes to promote Olympism. This year we had school students take part in Olympic Values activities at our new office, which included learning about the history of the Olympics, the role of a National Olympic Committee within the Olympic Movement and meet some of PNG’s Olympians.

On Olympic Day we took the sports of fencing, karate, basketball and boxing to members of the community through a sports demonstration day open to the public at Ela Beach. It was great to see many mothers and children from the nearby village of Wanigela take part in the fun-filled interactive sessions and try, what was for many, a new sport for the first time.

Our Team PNG HERO athletes also took the Olympic Values of Excellence, Friendship and Respect through the Olympic Values Education Program (OVEP) to schools and communities throughout the country, where their interaction with children of PNG was as rewarding for them as it was for the members of the communities. The highlight of OVEP in 2019 was the visit to the



schools and a community in Lake Kutubu in the Southern Highlands Province. Over the course of a week, Team PNG HERO Athletes Dennis Kopman, Nigel Bana, Raphaella Baki-Kaore, Betty Angula and Programs Coordinator Milton Kisapai visited Mubi Primary School, Tanuga Primary School, Lake Kutubu Primary School, Lake Kutubu Secondary School, Sisipia Primary School and Fogomau Primary School, reaching more than 1200 students and a village community in Lake Kutubu.

In addition to the OVEP sessions conducted in the schools, every afternoon Karate athletes Nigel and Dennis, Boxing athlete Raphaella and Basketball athlete Betty, ran training session in their respective sports with members of the local community of Fogomau, where the athletes resided. The impact of the visit on the community was expressed by Anne Hewago, the President of for Kutubu LLG Women's Council.

"It was a great honor to have you and the team here with us in Kutubu. It was a great blessings to my people of Kutubu, especially children, youths and parents; you and the team members presence, inspirational messages and the spirit of sharing and caring was amazing; you and the team

touched our hearts, broke our hearts and stole our hearts away."

Basketball athlete Betty Angula upon returning home to Mt Hagen after the 2019 Pacific Games conducted OVEP sessions with five schools in Mt Hagen. The schools visited were Mt Hagen Secondary School, Mt Hagen United Primary School, Mt Hagen Tarangau Primary School, Mt Hagen Holy Trinity Primary School and Mt Hagen Rabihamul Primary School.

The PNG Under 17 Basketball squads were also taken through OVEP sessions as part of team building and motivation prior to their participation in the U/17 FIBA Oceania Championships in New Caledonia.

OVEP sessions were also used as motivation for boxing athletes vying for a spot in the final squad leading up to 2019 Pacific Games. Boxing athlete Raphaella Baki organized the sessions and she also delivered OVEP sessions as part of her Kamapim Boxing Meri program. Raphaella organized a clinic for thirty-six women and girls to promote boxing as a way to build self-confidence, develop skills and stay healthy through physical activity in line

with the Olympic values.

An OVEP Booth was set up at the inaugural Hevea Cup and Wellness Expo, which was the first ever sports and wellness expo in PNG. Run by the Grass Skirt Project, the Hevea Cup saw a Rugby League 9's tournament ran simultaneously with a health and wellness expo to commemorate the International Women's Day. Over 4000 people of all ages visited the OVEP Booth to learn about the Olympic Values and reflect on how they could display friendship, excellence and respect in their everyday actions.

The Olympic Values were also promoted as part of celebrations held to commemorate the National Women and Girls Sports Day and the International Day of Sport for Development and Peace. Both events were organized by the PNG Sports Foundation and saw Team PNG HERO athletes deliver fun activities as part of the OVEP sessions. Team PNG Karate Athletes Nigel Bana and Julius Piku also ran self-defense lessons for all girls that participated in OVEP. The following is a quote from a student when asked if she enjoyed taking part in OVEP: "I enjoyed (the OVEP session) because it didn't just help me to be fit but also to do teamwork" - Santania Katato, Age 14.

A fun and interactive values based active learning program, OVEP continues to reach far and wide through the support of Exxon Mobil

Celebrating World Water Day at the invitation of World Vision, Team PNG HERO athletes raised awareness on the issue of plastic waste through the Love Your Coast program at Hagara Primary School. It was a whole school event with over 300 students participating in the program.

The Love Your Coast program was also incorporated into the World Vision organized Hanuabada village Clean Up program, which focused on water and sanitation issues faced by the villagers. The Team PNG HERO athletes carried out awareness and clean up activities in different locations of the village.

We conducted our 4th Team PNG HERO training in November. The program saw 25 HERO athletes become the first to complete and receive certificates for both the Team PNG HERO training and IOC

Career+ program. Covering a range of topics from the Olympic values and the Sustainable Development Goals (SDGs) to presentation skills and goal-setting, our 25 HERO athlete role models are ready to be agents of change and help build a better PNG through sport. The message we tell our HERO athletes is that they can draw on the same values and attributes that have made them successful in their sport to allow them to become successful in their lives outside of sport. They should inspire others not just from what they achieve on the sporting fields but also through what they do off the sporting field.

Eight athletes were accepted into the Athlete Excellence Program, a partnership with the Institute of Business Studies University, which offers scholarships to athletes for their diploma and certificate courses. Six athletes graduated with three athletes recognized for achieving grades that placed them in the top three students of their classes.

As part of our annual sponsors luncheon, we launched our Athlete Friendly Company program, which aims to provide athletes with employment opportunities with companies who join the program. Early success through the program has seen two athletes being employed in the sales sector.

More work will be done in 2020 to continue to provide our athletes with opportunities to inspire.

Milestone and Best Practice Achievements

Openness is one of four values of the PNGOC and we appreciate learning from the experience of others and actively seek out best practice examples. Likewise we are open to sharing from our experiences.

In 2019 the development of the NF Hub as a tool to address identified challenges faced by our NFs is something that may be of interest to other NOCs; not only because of the end product but also because of the process taken to develop and launch the hub.

The development of the NF Hub would not have been possible without the PNGOC's migration to Microsoft 365. Significantly this was achieved without having to purchase the software license.

The launch of the Athlete Friendly Company program has been a goal of the PNGOC and we were happy to see this accomplished in 2019. But we would like to see the

program develop and would welcome advice from our partners on how this can happen.

A momentous milestone for the organization and all who have been involved with the PNGOC over the years was the opening of the PNG Olympic Haus. We are proud to have it as a center to promote Olympism in PNG and be the base for the growth of the NOC.

Committed staff has always been a strong factor in the success of the organization. In 2019, two staff members celebrated significant employment milestones with the organization. Secretary General Auvita Rapilla commemorated 25 years with PNGOC and Finance and Admin Officer Laisani Samson celebrated 15 years of employment.



Challenges in 2019

The principal challenge of 2019 was mobilizing the financial resources required to cover the Team PNG budget for the 2019 Pacific Games. We were happy to have accomplished this with significant support received from Government.

Financial sustainability and raising the funds needed to provide the expected support for the Games preparation of athletes by our sports is a continuous challenge. We are exploring new sponsorship opportunities and means of attracting increased funding for our sports.

Issues related to selection of athletes for Team PNG were faced in 2019. The Justification Committee has proposed solutions to this reoccurring challenge based on the 2019 experience and the NOC will look to implement these moving forward.

The improvement in the governance of our NFs is something we will continue to pay attention to with our target to have all NFs one hundred percent compliant with our governance requirements. Finding the appropriate approach and measures to ensure this happens is a task we will continue to work on.

We approached these challenges with a positive outlook recognizing the opportunities they presented to improve our work.

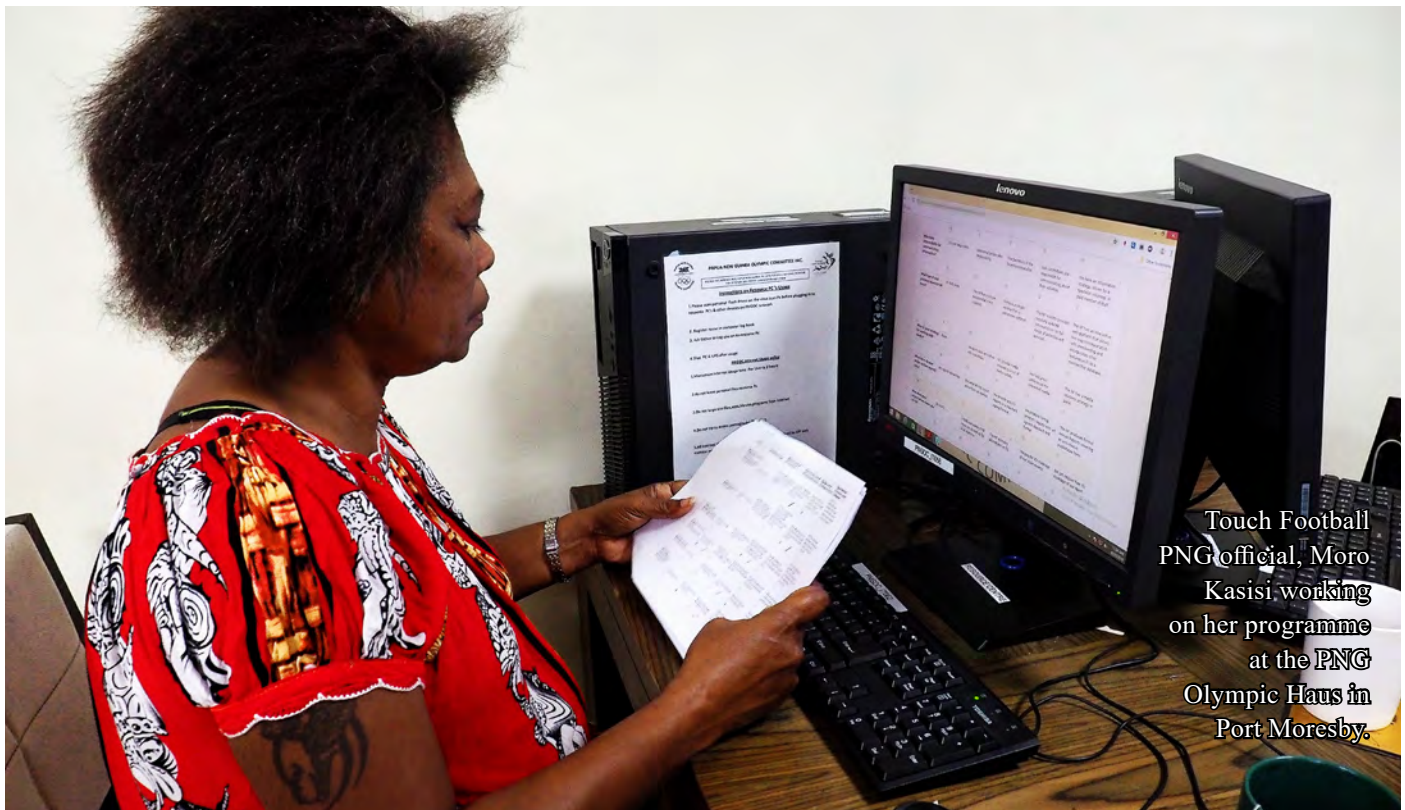
Conclusion

These structures have a significant impact on the performance of the Papua New Guinea Olympic Committee (PNGOC) as a sporting organisation, as well that of its members. It impacts how objectives are set and achieved, lays out the rules and procedures for decision making, and considers monitoring, risk and evaluation measures.

The Papua New Guinea Olympic Committee acknowledges and recognises that for sports governance to be effective, it requires good leadership, judgement and integrity, which all befittingly are aligned within the core values of Honesty, Excellence, Respect and Openness of the organisation.

In pursuit of this, the PNGOC and its members and

affiliates must continue to demonstrate transparency, accountability and responsibility in the activities undertaken and resources expended. Ineffective governance practices not only impact the sport, its athletes and members, but also undermines the confidence in the PNG sports industry.

The 2019 Governance and Compliance info graphic summary focuses on the Audit of Compliance which is an annual exercise carried out to ensure all members and affiliates of the PNGOC are coordinating its activities in line with their respective constitution, their international federations rules and that of the PNGOC. 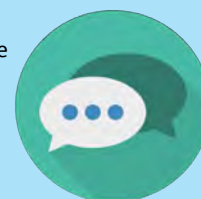

Independent Auditor's Report

To the Members of Papua New Guinea Olympic Committee Inc. (the "Committee")

Report on the audit of the Financial Report

Opinion

We have audited the Financial Report of Papua New Guinea Olympic Committee Inc. (the "Committee").

In our opinion, the accompanying Financial Report of the Committee is in accordance with the *Association Incorporation Act (Chapter 142)*, including giving a true and fair view of the Committee's financial position as at 31 December 2019 and of its financial performance for the year ended on that date.

The Financial Report comprises:

- statement of financial position as at 31 December 2019;
- statement of comprehensive income, and statement of cash flows for the year then ended; and
- notes including a summary of significant accounting policies.

Basis for opinion

We conducted our audit in accordance with the *International Standards on Auditing*. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the Financial Report* section of our report.

We are independent of the Committee in accordance with the ethical requirements of the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the Financial Report in Papua New Guinea. We have fulfilled our other ethical responsibilities in accordance with the Code.

We confirm that we have remained independent as required by the Code throughout the period of our audit and to the date of this Auditor's Report.

Basis of Accounting

Without modifying our opinion, we draw attention to note 1 to the financial statements, which describes the basis of accounting. The special purpose financial statements have been prepared for the purpose of fulfilling the Executive Committee's financial reporting responsibilities under the *Association Incorporation Act (chapter 142)*. As a result, the financial statements may not be suitable for another purpose.



Other Information

Other Information is financial and non-financial information in Papua New Guinea Olympic Committee Inc.'s annual report which is provided in addition to the Financial Report and the Auditor's Report. The Executive Committee are responsible for the Other Information.

Our opinion on the Financial Report does not cover the Other Information and, accordingly, we do not express an audit opinion or any form of assurance conclusion thereon.

In connection with our audit of the Financial Report, our responsibility is to read the Other Information. In doing so, we consider whether the Other Information is materially inconsistent with the Financial Report or our knowledge obtained in the audit, or otherwise appears to be materially misstated.

We are required to report if we conclude that there is a material misstatement of this Other Information, and based on the work we have performed on the Other Information that we obtained prior to the date of this Auditor's Report we have nothing to report.

Responsibilities of the Executive Committee for the Financial Report

The Executive Committee are responsible for:

- preparing the Financial Report that gives a true and fair view in accordance with the *Association Incorporation Act (Chapter 142)*;
- determining that the basis of preparation and accounting policies described in note 1 to the financial report are appropriate to meet the requirements of the Committee's constitution and is appropriate to meet the needs of the members;
- implementing necessary internal control to enable the preparation of a Financial Report that gives a true and fair view and is free from material misstatement, whether due to fraud or error; and
- assessing the Committee's ability to continue as a going concern and whether the use of the going concern basis of accounting is appropriate. This includes disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless they either intend to liquidate the Committee or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the Financial Report

Our objective is:

- to obtain reasonable assurance about whether the Financial Report as a whole is free from material misstatement, whether due to fraud or error; and
- to issue an Auditor's Report that includes our opinion.

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal controls.

If we conclude that a material uncertainty exists, we are required to draw attention in our auditors' report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditors' report. However, future events or conditions may cause the Committee to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

The auditor communicates with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that the auditor identifies during the audit.

The auditor also provides those charged with governance with a statement that the auditor has complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on the auditor's independence, and where applicable, related safeguards.

Report on other legal and regulatory requirements

We have obtained all the information and explanations, which, to the best of our knowledge and belief, were necessary for the purposes of our audit.

In our opinion proper books of account have been kept by the Committee, sufficient to enable financial statements to be prepared, so far as it appears from our examination of those books; and to the best of our knowledge and according to the information and explanations given to us the financial statements give the information required by the *Association Incorporation Act (Chapter 142)*, in the manner so required.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Papua New Guinea Olympic Committee Inc. is an association domiciled in Papua New Guinea. The address of the associations' registered office is at Sir John Guise Stadium Port Moresby, National Capital District Papua New Guinea. The association's principal activity is a non-government organization that represents the interests of its members, the National Sports Federations.

The Papua New Guinea Olympic Committee Inc. includes the National Olympic Committee, The Commonwealth Games Association, The Pacific Games Association, and the Fund Raising Committee.

The financial statements were approved at the Executive Committee Members Meeting held on the 10th June 2019.

(a) Subsidiary

The Papua New Guinea Olympic Committee Inc. owns 100% of the PNG 2015 Pacific Games Organising Committee, PNG 2015 Pacific Games Ltd. The investment in subsidiary is shown at nominal value representing value of share capital subscription.

(b) Basis of preparation

The financial statements have been prepared in accordance with the accounting policies as determined by the Association's executive committee that is consistent with the requirements of the Associations Incorporation Act and the financial reporting requirements as per the Association's constitution. The financial statements have been prepared on a historical cost basis applying the accrual accounting concept.

Special purpose financial statements

This is a special purpose financial report for the sole purpose of providing financial information to the members and must not be used for any other purpose.

The association is an exempt organization in accordance with Section 171 of the Companies Act 1997 as the members have elected to be exempt under Section 171 (1b).

(i) Presentation of financial statements

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, and have been applied consistently by the Association.

(ii) Foreign currency transactions

Transactions in foreign currencies are recorded at the exchange rate at the date of the transaction. Foreign currency monetary assets and liabilities are translated at the exchange rate at the balance date. Resulting exchange differences are recognised in the profit and loss account for the year. Non-monetary assets and liabilities denominated in foreign currency are recorded at the exchange rate at the date of the transaction.

(iii) Property, plant and equipment

Items of property, plant and equipment are stated at original cost less accumulated depreciation and impairment losses.

Depreciation is provided on cost amount of all fixed assets, including buildings so as to write off the assets progressively over their estimated useful lives. Fixed assets are first depreciated in the year of acquisition.

(iv) Impairment

The carrying amounts of all assets are reviewed at each balance date to determine whether there is any indication of impairment.

(v) Inventories

Sports wear and accessories purchased for past Olympic, Commonwealth and Pacific Games, but not yet used are valued at the lower of cost and net realisable value.

(vi) Provisions

Provisions are recognised when the association has a legal or constructive obligation as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation.

(vii) Taxation

The association is exempt from income tax under Section 27(b) of the PNG Income Tax Act as a sporting body.

(viii) Revenue

The major source of revenue for the association is grants and sponsorship income. Revenue is recognised when the funds are received.

(ix) Provisional reserve

The association allocates grants and sponsorship income to individual projects. The excess of such allocated income over expenditure are transferred from the Statement of comprehensive income into a "Provisional Reserve" and included as "Funds held in Trust" in the Statement of financial position.

Team PNG went to Samoa with the aim to make history by winning their first Pacific Games on foreign soil.

Justification Committee

The participation of all sports went through the full Justification process in line with Team PNG selection policy and Games performance standards.

Games Target

Team PNG set its target of creating history by topping the medal tally on foreign soil after a successful 2015 Pacific Games campaign on home soil.

PNG couldn't repeat the success from 2015 however, history was still created by winning a total of 131 medals which was the most medals won on foreign soil. This

surpassed the efforts in 2011 in New Caledonia where Team PNG claimed a total of 121 medals.

Results

PNG finished second on the Medal Tally claiming 39 Gold, 57 Silver and 35 Bronze for a historical feat of 131 medals claimed overseas. New Caledonia set the bar high claiming 75 Gold medals to clinch the top spot on the medal tally followed by PNG and hosts Samoa to round off the top three.

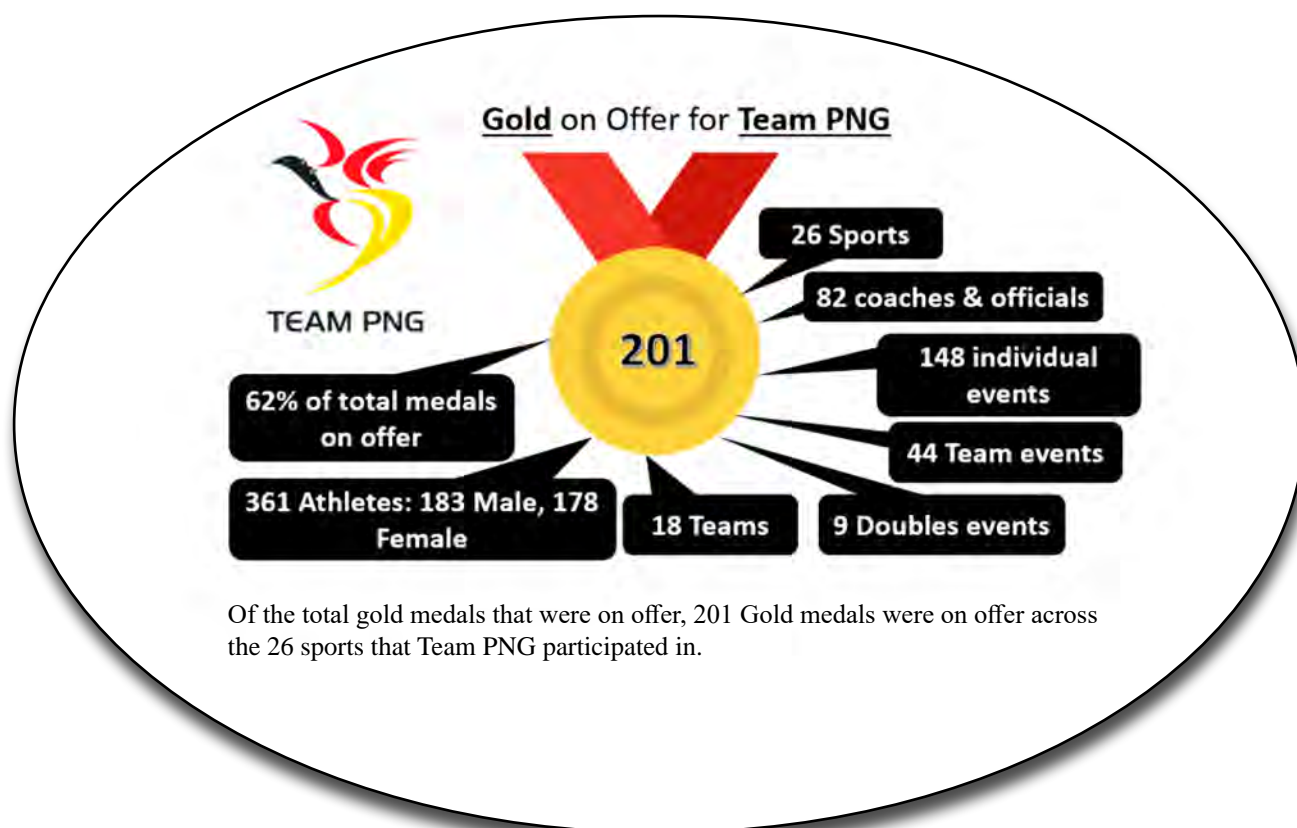

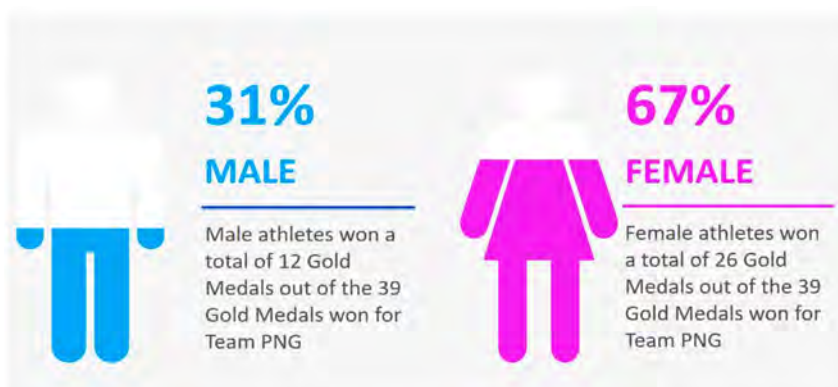

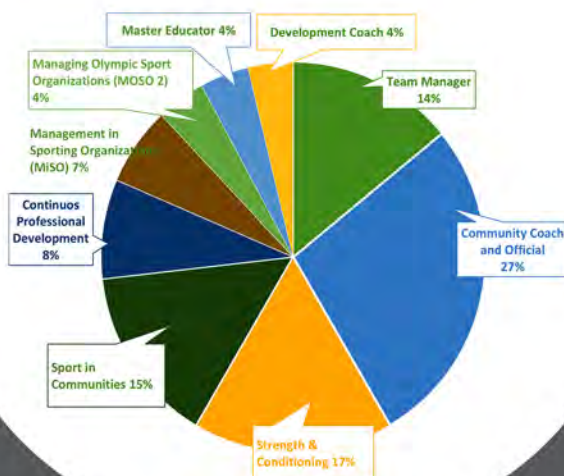

(PNGSI), both on the competition platform and in providing training and educational programs for our athletes and volunteers.

It was a year where we were able to gauge our future strategy to enable successful outcomes moving forward and to provide the best pathways to deliver our sport into the future, positively improving all areas in coaching, officiating and administering our sport.

We began the year by thanking outgoing Patron, Mr. Bart Philemon for his support of PNGSI since 2013. We were honoured and privileged to have him on our executive over the many years of his patronage.

The Council Meeting and the Annual General Meeting of PNGSI were held on 6 April, 2019. This saw the incoming executive members for 2019 being elected. They are:

The positions of the Property Officer and Public Relations were left vacant at the close of the AGM and later in the year, the position of Public Relations was filled by Ashley Seeto.

Our support partners and sponsors in 2019 were: FINA (Education, Competition, National Federation financial support program), Oceania Swimming Association (OSA), PNGOC, Bank South Pacific, and Theodist Limited and PNG Air Freight, who all enabled us to develop, strengthen and improve our activities throughout the year.

Education Pathways

Bank South Pacific provided valuable funding support (K80,000.00) towards our BSP National Aquatic Excellence program for our swimmers, and alongside FINA, the educational programs for our volunteers.



They were:

FINA Coaches Certification Course - Assistant Coach Level (L1), held in Port Moresby at the Taurama Aquatic Centre from 8 to 10 March, 2019. It was under the direction of FINA Coach Assessor, John Bladon which saw 15 Club coaches from Lae and Port Moresby become accredited.

FINA Technical Officials Workshop - held in Lae from 25 to 29 September in conjunction with the 2019 PNG TNT National Swimming Championships conducted by FINA Technical Swimming Committee expert, Lesley Huckins.

FINA programme "Swimming for All, Swimming for Life", PNGSI held its FINA Aquatics Day to celebrate aquatic sports on Saturday 16th November at the Taurama Aquatic Centre in Port Moresby, National Capital District and the primary campus of Lae International School pool in Lae, Morobe Province.

Competition Pathways

Competition sponsors, Theodist Ltd and PNG Air Freight (TNT) provided funding support of PGK10,000 respectively towards our two National Championship events, providing the opportunity for our young athletes to compete in the true spirit of sportsmanship.

1. **Theodist National Long Course**, Port Moresby, NCD (March 29-31).
2. **TNT National Long Course**, Lae, Morobe Province (September 27-29).

Our three International competitions were:

1. **Arafura Games**, Darwin, Australia (April 27-May 4) - 13 swimmers and 4 officials took part in the 2019 Arafura Games, bringing home

21 medals, including 15 individual and 6 relay medals.

2. **XVI Pacific Games** Apia, Samoa (July 7-19) - 10 swimmers and 2 officials were endorsed by PNG Olympic Committee to travel to the Samoa Pacific Games. Five PNG Technical Officials were invited to attend through an invitation from the Samoan Games Organising Committee and Technical Director to officiate. A Silver and a Bronze medal were awarded to Ryan Maskelyne for his 200m Breaststroke and 100m Breaststroke respectively.
3. **18th FINA World Swimming Championships**, Gwangju, South Korea (July 21-28) - A 4-member 2020 Tokyo Olympic Games train-on squad swim team and 3 officials represented

PNG. A PNG Record was recorded in the 4x100m Mixed Medley Relay in a time of 4:18.99 by swimmers, Sam Seghers, Ryan Maskelyne, Georgia-Leigh Vele and Judith Meauri.

2019 saw three of our present and past athletes named on various Athlete committees both Nationally and Internationally.

Our three affiliated Clubs; Boroko Amateur Swimming Club (BASC), Lae Amateur Swimming Club (LASC) and PNG Masters, provided the setting for our athletes to train, stay motivated, develop new skills, and participate in competitions such as Club Carnivals and Club Championships.

Our coaches ensured that appropriate opportunities were provided for competition and, that our athletes can participate in a positive, effective and safe enjoyable sporting environment. PNG is fortunate enough to have some very hard-working volunteer coaches to provide the necessary education and teaching skills to our younger generation of swimmers.

The PNGSI BSP Kundu National Aquatic Excellence

Program provided an added incentive for athletes to triumph, a pathway to strive for achievement and success with the emphasis that sport is an important part of a child's total development, helps develop fitness, social skills and self-esteem that can be carried on into adulthood.

The Oceania Swimming Association (OSA) held a 2-day strategic planning workshop and AGM in Nadi, Fiji on 15-16 June, 2019 for all its National Federation affiliates. The workshop was made possible through the FINA Continental funding support to OSA. PNGSI was represented by 2 delegates and 2 athlete representatives.

Sadly, our Oceania region lost a great friend in swimming, Mr Dennis Miller (OSA President / FINA Vice President) who passed away on the 1st June prior to the workshop.

PNGSI, also sadly saw the passing of LASC swimmer 18-year old Tanguy Langelet on the 31st August (a member of the BSP National Target Excellence Squad).

The last quarter of 2019 provided a time for reflection for all, a time to plan and set goals and be





fully motivated to continue working for the benefit and support of all affiliated members to PNGSI. As we journey into 2020 our aim is to do more, and do it better, understanding that the sweetest victory is the one that's most difficult. KUNG FU WUSHU ASSOCIATION OF PAPUA NEW GUINEA

Activity Report 2019

Introduction

This year was a special one for the Kung Fu Wushu Association of PNG (KFWA PNG) since it marked our first year in existence after completing all the formalities.

Within this short period the Association moved quickly to ensure that we complied with all the requirements for our membership and affiliation to our partners and stakeholders. This was not easy due to the limited funding support and resources we have but it was a good relief to see some of the main events come to fruition.

Coaching and Support

Two of our first important events were the introduction of Wushu as a modern sport particularly in the discipline of Sanda (free fighting). Assisting PNG with this was the Oceania Kung Fu Wushu Federation (OKFWF) and the Chinese Wushu Association (CWA).

Our first Wushu seminar was a one-day coaching clinic with the Australian High Performance Coach for Sanda, Robert Williams. It was held on April 7th at the Car Club in Port Moresby. Over 40 athletes from traditional Kung Fu Wushu and other martial arts backgrounds attended the event.

A second coaching seminar was held with the national coach of the Chinese sanda team, Su Yongwei on June 2nd and 3rd at the Car Club and Taurama Indoor & Aquatic Centre in Port Moresby. Yongwei was a member of a three-person delegation which also had the President of CWA and its Secretary.

First National Squad

The first national development Wushu squad for PNG was selected this year. It had 15 athletes which consisted of 12 men and three women. They were under the guidance of senior athlete and KFWA PNG National Development Officer, Andrew Molen. The squad was;

Male athletes; Dickson Walter, Tony Mitu Junior, Bostany Elo, John Kevin, Patrick Kasamento, Liawe Michael, Cosmas Saliawali, Cyprian Luvi, Petrus Sam, Gabriel Saeni. Axel Kevin, Andrew Molen.

Female athletes; Bellanie Kambari, Tattiana Abola, Audrey McRubin.

The focus of the training programme covered two disciplines;

- Taolu (forms)
- Sanda (free fighting)

While the modern Wushu taolu programme is still in development, we decided to start preparing the athletes for it. The Association's main focus now is Sanda.

Partnership with High Performance Sport PNG

Part of KFWA PNG's development programme is to have a high

performance training programme and we were delighted to sign a MoU with the PNG Sports Foundation's High Performance Sports division to ensure this.

Following the agreement, our development squad was put through a Strength and Conditioning programme which began in August and ran for the rest of the year.

Wushu Coaching in Shanghai

With the support of CWA and OKFWF, we were able to send our National Development Officer, Andrew Molen to the Shanghai University of Sport for a two-week wushu training programme for high level coaches. He was among coaches from around Asia and Europe and South America. It ran from October 6th to 18th, 2019.

First World Wushu Championships

PNG attended its first ever World Wushu Championships in 2019 when Andrew Molen attended the 15th Edition of the event which was held in Shanghai, China from October 19th to 23rd.

Due to technical difficulties, Molen could not compete however, he also took the time to represent PNG on behalf of the Association at the International Wushu Federation's Congress held there as well. It was at this Congress that PNG was voted in as a full member of the

Internaton Wushu Federation (IWUF).

Challenges faced

Within our first year of establishment we secured five member clubs around the country where we will be running our programmes with. However, the main difficulty faced in getting to them was due to lack of funds and resources.

The other was having a good training venue where students and athletes can meet and train together regularly. Interest has been overwhelming from the public and within the sports fraternity but most stopped coming when venues change and distance proved difficult for them.

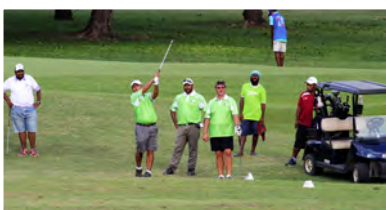
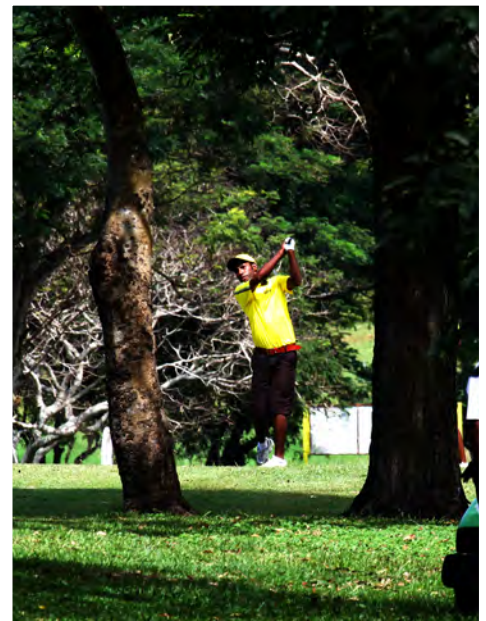
Conclusion
