

#### INTRODUCTION

#### 2021 marks 60 Years of our existence as a National Olympic Committee.

To thrive into the future, we need to understand and appreciate the rich history of sport in the country and the impact it has on our communities and its individuals. As we reflect on the struggles and achievements of the past 60 years, we can marvel at the vast improvements and possibilities ahead for the current and future crop of Team PNG athletes and our member and affiliate National Federations.

We acknowledge those volunteers and sports administrators before us who paved the way for what we are able to enjoy and participate in today. Collectively with today's current crop of sports administrators and athletes past and present, we are proud of our achievements under the Team PNG banner and the respective games movements we serve.

Unprecedented challenges in running our fundraising events, hosting our annual general assembly, adapting to changing technological requirements amongst other things has forced us to become more collaborative and champion our values of honesty, excellence, respect and openness as we strive to be more innovative and work towards optimistic outcomes.

The Papua New Guinea Olympic Committee will continue to adapt and respond to these challenges through the leadership of our President and Executive Board as we work towards supporting Team PNG, our members and affiliates as we continue our work in the Olympic, Commonwealth and Pacific Games Movements.

#### KEY ACTIVITIES UNDERTAKEN IN 2021 INCLUDE:

#### **TOKYO 2020 OLYMPICS**

Despite a turbulent build up to Tokyo 2020, we were delighted to send a small contingent to Japan for the postponed Tokyo 2020 Olympic Games held from 23rd July to 8th August 2021.



Our Olympic team did well, a new experience and games in which we debut five new Olympians for the country with several athletes going on to achieve personal bests at the games.

We are grateful for the support from our family of corporate partners and stakeholders including the Australian Olympic Committee and the Australian Government through its PacificAus Sports program. Their support enabled

PNGOC and PNG to send a Team PNG contingent of 8 athletes and 11 officials led by Chef de Mission Tamzin Wardley, to Tokyo.



Amongst the eight athletes, five athletes made their Olympic debut as they joined an elite list of athletes to have donned the red, black and gold at an Olympic Games. The five athletes of Rellie Kaputin (Athletics), John Ume (Boxing), Ryan Maskelyne (Swimming), Rose-Lee Numa (Sailing) and Teariki Numa (Sailing) became proud Olympians as they endeavoured to achieve their individual targets as they competed against the world's best athletes within their sport.

In a first for the Olympics and Team PNG, we had two flag bearers at the games which was endorsed by the International Olympic Committee in March 2020 requiring all National Olympic Committee to nominate two flag bearers, a male and a female. Team PNG was represented by weightlifting Olympians Dika Toua and Morea Baru.

Highlights of the Tokyo 2020 Olympic Games included Morea Baru finishing tenth in the men's 61kg division, Rellie Kaputin finishing in the top 20 in the Women's Long Jump, Ryan Maskelyne breaking the national record and his personal best in the 200m Breaststroke event.





Judith Meauri won her heat in the Women's 50m Freestyle, John Ume fought valiantly in the Men's 63kg event against the Australian that went on to win Australia's first Boxing medal in over 30 years and sibling sailors of Rose-Lee and Teariki Numa sailed nobly on the waters.

Dika Toua becoming the first female Weightlifter to lift at five Olympic Games. Dika also created similar and parallel history when she became the first and youngest female lifter at the tender age of 16- years to participate when the sport was

introduced during the 2000 Olympics in Sydney, Australia.





#### 2021-2024 STRATEGIC PLAN LAUNCH

In the midst of the COVID19 pandemic, the Papua New Guinea Olympic Committee opted for a soft launch of its new Strategic Plan for the 2021-2024 period. The New Strategic Plan has four key focus areas for the organisation and its members and stakeholders. The planning process commenced in August 2020 through an external consultant, of which was an inclusive review and refinement process that involved National Federations, athletes and coaches, working committees, board, management and staff; the development of a Games Performance Strategy, both culminating in finalised documents in April 2021.



Aligning itself to the ideals of the Olympic Movement, Commonwealth Movement and Pacific Games Movement, the PNGOC has refined its vision to "Inspire and unite Papua New Guinea through Sporting Excellence and Success", whilst maintaining its values of Honesty, Excellence, Respect and Openness.

The four key focus areas over the next four years are:

- 1. Excellence Embodied and Strategic Partnerships
- 2. Consistent Success for Team PNG
- 3. Develop the Solidarity amongst and Capability of National Federation and Athletes
- 4. Sport in Society

I would like to acknowledge and thank the Executive Board both past and present who embraced their responsibilities as custodians of the culture and strategic priorities under the 2016-2020 strategic plan.

#### **2021 ANNUAL GENERAL ASSEMBLY**

Our annual general meetings allows us to report to our members, affiliates and wider stakeholder audience about our strategic direction progress, use of resources and discuss issues of importance to our members. Pleasingly we ended off on the right balance as we finished off our 2016-2020 Strategic Plan through the collaborative efforts of our committees, Executive Board, National Federations, sponsors and stakeholders.

The Papua New Guinea Olympic Committee was delighted to have Teqball PNG voted in as its newest member at the June AGM. Teqball is the latest sport to be added to PNGOC's growing membership list. The newly formed sport was elected in as a new member National Federation (NF) to bring the total number of NFs to 40 members and affiliates.

In addition, the Papua New Guinea Olympic Committee was introduced to the New Treasurer Mr. Peter Davani who took up the vacant Treasurer position. It was also the first time in our history to trial a hybrid (physical and virtual) AGM in which Tennis and Athletics joined our meeting via the virtual platform.





#### OYLMPIC DAY/WEEK

Through the facilitation ExxonMobil PNG, the Papua New Guinea Olympic Committee was able to commemorate the Olympic Week with the rest of the Olympic Movement when restrictions were lifted in June. Several of our member National Federations sports were introduced to students from five (5) selected primary schools within the National Capital District to learn and live out the three (3) Pillars of Olympic Day "Learn, Move and Discover".



A three (3) day sports demonstration in Port Moresby was carried out at the Port Moresby Racquets Club and ended with a Mangrove Planting activity at Gwarumemase, which is situated in the Bootless Bay. Sports on showcase included Tennis, Squash,



Badminton, 3x3 Basketball, Teqball and Parkour. Schools that participated in the Olympic Day Sport Demonstration and Olympic Values Education Program included Wardstrip Primary School, Ted Diro Primary School, Butuka Primary School, Bavaroko Primary School and Butuka Primary School.

#### OCEANIA SPORTS EDUCATION PROGRAM

Our Games and Programs Division was able to hold and achieve some of its set events in 2021 with the delivery of a range of activities together with the support of our partners. These included the OSEP Community Coach and Official, Sport in Community Administration and Gender Equity Workshops in June in Port Moresby, and the Oceania Sport Education Program (OSEP) Consultation workshops in three (3) provinces including online sessions.



#### ANTI-DOPING

As part of PNGOC's commitment to clean sport, testing, education and awareness sessions were done for athletes and officials. Our efforts covered conducting out of competition tests, education and awareness sessions for the Tokyo 2020 Olympic Games targeted athletes and officials.

In November of 2021 there was a Master Educators Refresher course held which was split between the two programs the Oceania Sports Education Program (OSEP) and the Oceania Regional Anti-Doping Organisation (ORADO). The National Lead Master Educators for ORADO in PNG who attended were Janet Gimots and Asiani Vagi. The National Lead Master Educators for OSEP who attended were: Alurigo Ravusiro, Sophia Tuna, Geoffrey Gabriel



#### **OLYMPIC VALUES EDUCATION PROGRAM (OVEP)**

The Olympic Values Education Program, which is proudly supported and funded by ExxonMobil PNG was delivered in Lake Kutubu in May and June of 2021.

The program was delivered through the following five (5) HERO athletes representing their respective National Federation – Denis Kopman (Karate), Nigel Bana (Karate), Raphaela Baki (Boxing), Betty Angula (Basketball) and Milton Kisapai (Hockey).

The HERO athletes took the program through six (6) schools) reaching an audience of 1200 students and their surrounding village(s).



#### ATHLETE EXCELLENCE PROGRAM

Under the Athlete Excellence Program, the Institute of Business Studies University (IBSU) increased the number of scholarships for Team PNG athletes to take up studies with the IBS College of TVET and IBSU enabling our athletes with formal certification in their chosen field for life after sport. An extremely important partnership for Team PNG which we are grateful for.

Team PNG, the Papua New Guinea Olympic Committee, its member National Federations and the wider community has benefitted and will continue to benefit from this arrangement that prepares our athletes for a life after sport.

#### KICKS FOR KOKODA

The Papua New Guinea Olympic Committee attended the Relationships Skills Curriculum training of Coaches in Kokoda under the Kicks 4 Kokoda Project. This project is a two-year project in collaboration with Kokoda Track Foundation and Grassroots Soccer, and supported by Team Up Program from the Australian Government. The program uses sport for development to empower adolescents, increase health-seeking behaviours and promote gender equality while strengthening passion for sport.

Our main activity in the project is to deliver four tournaments in Kokoda and Buna at the end of the SKILLZ training. The tournaments will be delivered by Team PNG HERO athletes who will also deliver on the Olympic Values Education Program in the tournament.





#### **OTHER PROGRAMS**

The Papua New Guinea Olympic Committee participated in the following programs including the Sports Positive Next Generation Summit of which the organisation was represented by Milton Kisapai who was part of a panel of speakers who spoke on how professional and organized sports can use their reach to drive societal change on climate.

Under the International Olympic Committee's (IOC) Olympic Solidarity Scholarship, Alurigo Ravusiro graduated with an Executive Masters in Sport Organisations Management. She developed a project and wrote a dissertation on: "Maximizing Opportunities for National Federations in Papua New Guinea Through Partnerships. Looking through the lens of the Australia & Papua New Guinea bilateral relationship.



As part of the Love Your Coast Program, Team PNG HERO athletes celebrated World Coral Triangle Day in collaboration with the Conservation and Environment Protection Authority on Motupore Island.



The activity was also in line with the Sustainable Development Goals 13, 14 and 15, and also the Love Your Coast Program. The athletes also took time to learn about coral farming and restoration. In addition, on World

Environment Day, Team PNG athletes took part in preparing 6000 mangrove seedlings at the Sir Hubert Murray Stadium that were transplanted around Port Moresby.



#### **TEAM PNG PERFORMANCE**

During the 2021-2024 Strategic Planning process we were able to develop a focused Team PNG Performance Strategy. The Team PNG Performance Strategy aligns with the key focus area number two which looks at consistent success for Team PNG.

The Team PNG Performance Strategy will proudly shape the performance and delivery of our high-performance targets to reach our goal of Team PNG success on the international stage through targeted programs in the coming years.

Having a documented strategy allows us to be more intentional with our programs and resources to ensure that every opportunity is accorded to Team PNG to be successful and competitive at every multi-sport games we attend. Our vision for Team PNG is to be the best performing Pacific nation at all major multi-sport Games it competes in from 2021 through to 2024. The Performance Strategy sets the framework around future growth and success in this area.

With eighteen programs focused on five key areas including support to targeted elite athletes, performance-based

standards, development pathways, elite performance expertise and the formation of the Team PNG's Performance Partnership, we are well on our way to drive and deliver on the overarching goal of Team PNG success.

This is done through the newly developed Resource Allocation Policy and the NF/Athlete tiering system policy developed in 2021. Two guide-



lines were also developed to assist NFs with developing their respective High Performance Plans and sport specific selection policies. Support to elite athletes aims to be strategic and targeted that leads towards achieving Team PNG's vision of being the best pacific nation at all multi-sport Games.

Team PNG's selection policies for athletes and officials were also updated to reflect the current circumstances which saw the PNGOC board endorse the changes of making COVID-19 vaccination mandatory to be part of Team PNG. With international travel only allowing vaccinated individuals to travel, it was a necessary step to take in order to minimise travel difficulties and to safeguard the athletes and officials that will be part of Team PNG for future Games.

The formation of Team PNG's performance partnership was the priority of the strategy that saw key stakeholders come together towards achieving Team PNG's vision of being the best performing Pacific nation. The first meeting of the partnership saw the presenting of Team PNG's Performance Strategy to the Minister for Sports, Higher Education, Research, Science and Technology, Hon Wesley Raminai, PNGSF Executive Director, Albert Veratau along with National Sports Institute and High-Performance Sport PNG. The partnership also includes representatives from the National Federations.

Kumul Consolidated Holdings Ltd came on board to collaborate with PNGOC to assist with funding support to implement Team PNG's Performance Strategy, which has seen initial support provided to several National Federation's with domestic competitions within their high- performance plans.

Athletics PNG was one of the first NFs to receive support through the strategy and KCHL, which saw them run their National Championships in Kimbe in early December

#### **FUNDRAISING EVENTS**

Marred by lockdowns again in 2021, we were not able to stage our two main fundraising activities under the banners of the long running annual Trukai Fun Run (TFR) for the second consecutive year since 2020, and the Prime Minister's Corporate Golf Challenge in 2021.

These fundraisers provide much needed support for Team PNG to the multi-sport games, as well as funding to other essential activities undertaken by the PNGOC to strengthen its member National Federations and their athletes and officials.

While the annual Trukai Fun Run was not possible this year, the close and good working partnership with Trukai Industries Ltd saw collaborated and coordinated sales of the T-shirts which enabled a total of 25,000 T-shirts sold within a period of just under 3 months, before the Tokyo Games.

We would like to extend our gratitude to the organisations and individuals that supported with the purchasing of t-shirts despite the event not going ahead.



#### **VIRTUALISATION OF EVENTS AND MEETINGS**

With social distancing now practiced and going virtual is preferred, we acknowledge the Board, management and Staff of EMTV for partnering with us to air the first Team PNG Virtual Farewell, prior to the Tokyo games. This option was taken due to the majority of our athletes, coaches and team managers being based overseas in addition to complying with the existing COVID requirements at play.



We would also like to acknowledge and thank the support of major sponsor SP Brewery and supporting sponsors in delivering the 28th edition of the SP Sports Awards, a virtual first in 2021 which was held to recognise achievements in 2019 and 2020. In addition we would like to also acknowledge and thank our guest speaker for the event, our 2019 Hall of Fame Inductee Takale Tuna.

#### PNGOC PARTNERS

the supply and design of the Team PNG Walkout Wear to the Tokyo Games, Brian Bell Group with their "B the Best' Olympic Campaign"; City Pharmacy Limited Vouchers for Team PNG; and the National Gaming Control Board (NGCB) and Kumul Consolidated Holdings Limited (KCHL) provided much needed support to assist the PNGOC with sending Team PNG to Tokyo. As a non-government organisation (NGO), we are indebted to the continued commitment and partnership from our family of corporate partners, despite the new challenges imposed by the coronavirus to the economy and businesses in the country.

#### 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Papua New Guinea Olympic Committee Inc. is an association domiciled in Papua New Guinea. The address of the associations' registered office is at Section 25 Lot 21 Lahara Avenue, Port Moresby, National Capital District Papua New Guinea. The association's principal activity is a non-government organization that represents the interests of its members, the National Sports Federations.

The Papua New Guinea Olympic Committee Inc. includes the National Olympic Committee, The Commonwealth Games Association, The Pacific Games Association, and the Fund Raising Committee.

The financial statements were approved at the Executive Committee Members Meeting held on the 30th May 2022.

#### (a) Subsidiary

The Papua New Guinea Olympic Committee Inc. owns 100% of the PNG 2015 Pacific Games Organising Committee, PNG 2015 Pacific Games Ltd. The investment in subsidiary is shown at nominal value representing value of share capital subscription.

#### (b) Basis of preparation

The financial statements have been prepared in accordance with the accounting policies as determined by the Association's executive committee that is consistent with the requirements of the Associations Incorporation Act and the financial reporting requirements as per the Association's constitution. The financial statements have been prepared on a historical cost basis applying the accounting concept.

#### Special purpose financial statements

This is a special purpose financial report for the sole purpose of providing financial information to the members and must not be used for any other purpose.

The association is an exempt organization in accordance with Section 171 of the Companies Act 1997 as the members have elected to be exempt under Section 171 (1b).

#### (i) Presentation of financial statements

The accounting policies set out below have been applied consistently to all periods presented in these financial statements and have been applied consistently by the Association.

#### (ii) Foreign currency transactions

Transactions in fereign currencies are recorded at the exchange rate at the date of the transaction. Foreign currency monetary assets and liabilities are translated at the exchange rate at the balance date. Resulting exchange differences are recognised in the profit and loss account for the year. Non-monetary assets and liabilities denominated in foreign currency are recorded at the exchange rate at the date of the transaction.

#### (iii) Property, plant and equipment

Items of property, plant and equipment are stated at original cost less accumulated depreciation and impairment losses.

Depreciation is provided on cost amount of all fixed assets, including buildings so as to write off the assets progressively over their estimated useful lives. Fixed assets are first depreciated in the year of acquisition.

#### (lif) Property, plant and equipment (continued)

The straight line method of depreciation is used and the rates of depreciation used are:

Office equipment 30% Motor vehicles 25% Furniture and equipment 12.5% Buildings 4%

#### (iv) Impairment

The carrying amounts of all assets are reviewed at each balance date to determine whether there is any indication of impairment.

#### (v) Inventories

Sports wear and accessories purchased for past Olympic, Commonwealth and Pacific Games, but not yet used are valued at the lower of cost and net realizable value.

#### (vi) Provisions

Provisions are recognised when the association has a legal or constructive obligation as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation.

#### (vii) Taxation

The association is exempt from income tax under Section 27(b) of the PNG Income Tax Act as a sporting body.

#### (viii) Revenue

The major source of revenue for the association is grants and sponsorship income. Revenue is recognised when the funds are received.

#### (ix) Provisional reserve

The association allocates grants and sponsorship income to individual projects. The excess of such allocated income over expenditure are transferred from the Statement of comprehensive income into a "Provisional Reserve" and included as "Funds held in Trust" in the Statement of financial position.

## Message by PNG Olympic Committee President Sir John Dawanincura, Kt OBE

"Start by doing what's necessary; then do what's possible; and suddenly you are doing the impossible".

- Francis of Assisi

HEN I think about this quote, I think back to 1961 when Papua New Guinea witnessed the birth of the British Empire and Commonwealth Games Association, today commonly known as the Papua New Guinea Olympic Committee. Those were simpler times when the main goal behind the formation of the Papua New Guinea Sports Union was to enable the territory of Papua and New Guinea to participate in the 1962 British and Commonwealth Games and the inaugural South Pacific Games in Fiji in 1963.

Soon after the 1963 South Pacific Games we realised that we did not have a recognised national sporting body to enable the participation of Papua New Guinean athletes in other international competitions abroad. So, we did what was necessary, we worked on getting recognition for our established body, at times from the trunk of my car, with no budget, office space or paid staff but pure sweat and passion from our pioneer volunteers.

The organisation went by several different names during that period of growth. From the British Empire and Commonwealth Games Association, through to the Papua New Guinea Sports Union, the Papua New Guinea Amateur Sports Federation, the Papua New Guinea Sports Federation, the Papua New Guinea Sports Federation & Olympic Committee to its current name the Papua New Guinea Olympic Committee Inc. Despite the changing names over the years, our purpose and commitment has remained the same.

Come 1974 our efforts were rewarded when the Papua New Guinea Olympic Committee was finally accorded National Olympic Committee status. This then enabled us to participate in our first Olympic Games in 1976 in Montreal. Our recognition by the International Olympic Committee would open up the doors to many opportunities for the development of sports and the participation of our athletes in vari-

ous international competitions over the ensuing years. This is where we started to think – what's possible for

Since 1962 we have lived out our charter to prove what is possible to the everyday Papua New Guinean and organisation. As a country and recognised sporting body that bids for and attends these international games we have gone on to host three Pacific Games, the 1969 and 1991 South Pacific Games and 2015 Pacific Games. We have participated in 11 Olympic Games, 14 Commonwealth Games, 16 Pacific Games, 10 Pacific Mini-Games, 3 Youth Olympic Games and 4 Commonwealth Youth Games.

All of these international competitions that we have attended, and hosted domestically over the past 60 years would not have been possible without the backing and support of key stakeholders, the National Government of that time and partnerships engaged along the way.

Back then corporate sponsorship for sporting events and attendance was such a foreign concept. I recall trying to obtain corporate sponsorship from our then business community. Once that was possible we thought getting the government's support did not seem so impossible, all the whilst maintaining our autonomy.

Partnerships and collaborations with key stakeholders over the last 60 years have been the cornerstone to the very existence of this organisation. First and foremost, we are a non-governmental, not for profit organisation.

We are dependent on fundraising, sponsorship and the national government through the PNG Sports Foundation to support our endeavours in ensuring our elite athletes are better prepared to compete at all international competitions.

What has transpired over the last 60 years has been somewhat impossible if you were to ask the 30-year-old version of me. We have been around the world flying the PNG flag, grown and matured through strong leadership and good governance to create an autonomous, and sustainable organisation that will out live me long after I am gone.

We have come a long way from payphones and type writers and no budgets to a secured and permanent home on Lahara Avenue in Boroko officially purchased in 2019 and today referred to as the PNG Olympic Haus with a healthy organisation that is fully functioning with fulltime Secretariat.

The organisation will continue to work tirelessly in the years to come to ensure Papua New Guinea's participation at major international events, as well as ensuring the development of sport and the utilisation of sport for development in Papua Naw Guinea

I would like to personally thank everyone for their commitment and contribution towards our journey over the past 60 years. From our Executive Board members past and present, the respective National Governments throughout the years, sponsors and partners past and present and our members and affiliates both past and present.

It would be remiss of me if I did not thank our pioneers, Team PNG athletes, Olympians, Hall of Fame inductees and volunteers who have contributed immensely in our efforts for international participation and recognition.

In closing, I can say that despite the challenging and at times confronting periods in the Papua New Guinea Olympic Committee's history, we have always focused on doing our best for our athletes and officials and doing what's necessary and then doing what's possible to inspire and unite Papua New Guinea through sporting excellence and success

The Papua New Guinea Olympic Committee (PNGOC) is a non-government, notfor-profit organisation committed to inspire and unite Papua New Guinea through sporting excellence and success

The PNGOC is the recognised National Olympic Committee (NOC), Commonwealth Games Association (CGA) and Pacific Games Association (PGA) for Papua New Guinea; as such it is responsible for sending Team PNG to the Olympic Games, Olympic Youth Games, Commonwealth Games, Commonwealth Youth Games, Pacific Games and Pacific Mini-Games. It is also the body that can bid to host these Games with Government support.

Within the Olympic Movement the PNGOC is one of the 206 NOC members of the Association of National Olympic Committees (ANOC) and one of 17 member nations of the Oceania National Olympic Committees (ONOC). We are one of 72 CGA members of the Commonwealth Games Federation and one of 24 PGA members of the Pacific Games Council.

In line with the accepted principle of independence and autonomy of sport, the PNGOC is a non-government organisation with membership of 40 National Federations of Papua New Guinea (eg. Athletics PNG, PNG Netball Federation, PNG Football Association, etc).

It is our responsibility to select and send Team PNG to the Olympic Games, Commonwealth Games and Pacific Games. This is achieved by working with our member national federations and with the support of our sponsors and partners, through fundraising events and with the backing of the Government.

Through a Memorandum of Understanding we work in close partnership with the PNG Sports Foundation, the Government sport agency, for the development of Sport and the use of sport for development in Papua New Guinea.

PNGOC is a believer of sport as an enabler for sustainable and inclusive development. In line with the affirmation of the United Nations that sport is an enabler for sustainable development, PNGOC with its partners also contributes to building a peaceful and better world through sport and the Olympic ideal by educating youth through sport practiced in accordance with Olympism and its values of Excellence, Friendship, and Respect.



# PNGOC Celebrating 6

# Papua New Guinea Olympic Committee's 60 Year Journey

Thas been 60 Years of self-serving instinct that has brought about iconic sporting moments in Papua New Guinea, let alone the organisation that is the Papua New Guinea Olympic Committee (PNGOC). What is nationally recognised is also vey personal to us. As we celebrate 60 Years of existence, we remain inspired and humbled by our inheritance from those passionate and pioneering volunteers that paved the way for our current status.

Since its formal establishment in August of 1961, the PNGOC's mission has always been to enable our elite athletes to participate at national and international levels specifically in the four-year cycle of events of the 3 Games Movements; the Pacific Games, Commonwealth Games, Olympic Games, the Olympic and Commonwealth Youth Games and the Pacific Mini Games.

It has been a remarkable journey that has seen the organization transform from our humble beginnings as a group of dedicated volunteers eager to see the athletes from the Territory of Papua and New Guinea compete at the British Empire and Commonwealth Games and the South Pacific Games, to an organization of committed employees backed by the support of passionate stakeholders, still equally devoted to seeing Team PNG participate in and perform well at international sporting events.

The slow transition into a more professionalized body began in September 1984 with the appointment of John Dawanincura as the Secretary General the first employed staff, to 17 full time staff today operating from its own headquarters, the PNG Olympic Haus, which was purchased in 2018.

When dealing with our respective international sporting bodies, we take on the name of those events; the Papua New Guinea Pacific Games Association (PNG PGA), the Papua New Guinea Commonwealth Games Association (PNG CGA) and the Papua New Guinea National Olympic Committee (PNG NOC).

In these 60 years the membership has grown from a handful of four (4) sports to 40 currently affiliated National Federations (NFs). Throughout the years we have bid and successfully hosted three Pacific Games in partnership with Government and Corporate Partners, the 1969 and 1991 South Pacific Games (formerly called) and 2015 Pacific Games and participated in 11 Olympic Games, 14 Commonwealth Games, 16 Pacific Games, 10 Pacific Mini Games, 3 Youth Olympic Games, and 4 Commonwealth Youth Games.

An important cornerstone for our success is the contribution by countless volunteers whose contributions have been a vital and lasting part of our 60-year history. The first executive members of the Territory Amateur Sports Union consisted of Les Michel as President, Fred Kaad as Vice President and Cyril McCuberry as Secretary General.

Other members included Dame Rachel Cleland, wife of Administrator Sir Donald Cleland, both devoted sports enthusiasts, Fred Townsend, Peter Cornes, Reg Johnstone, Sam Piniau, Jack Pini, Sir Henry ToRobert, Bruce Flynn and his wife Rita Flynn were some who were heavily involved in laying the foundation for what our organization is today.

Their association with the organization in those days working with a skeleton operation, having no budget and
no office space to work from, was indicative of their passion and love of sport
and the firm desire to see PNG succeed
in sport. Operating as a non-government organization (NGO) in such circumstances made the mammoth task of
developing our national sporting bodies
and preparing our athletes for international competition more challenging.

The PNGOC over the last 60 years has grown from strength to strength with sound administration and good governance in line with the International Olympic Committee's (IOC) Basic Principles of Good Governance. The PNGOC holds its Annual General Assembly each year presenting its annual report and audited financial statements to its member National Federations as required under its constitution as part of best practice.

Enhancing the capacity of our member National Federations has been a key focus in particular strengthen their governance structures whilst achieving their high performance targets which contribute towards Team PNG's games targets. An estimated 90% of National Federations are run by passionate volunteers who devote their time and effort to the sport they love. The PNGOC recognises the importance of National Federations in the development of their respective sports in the country and it works with them to develop their capacity to fulfill their respective mandates

Since the establishment of the Women in Sport Committee (now Gender Equity Committee) in 2000, there has been a gradual growth in female participation at all levels of sports in Papua New Guinea. About 45% female athletes make up Team PNG and since 2011, more than 50% of Team PNG Gold medals were won by our female athletes. The last decade has seen an increase in female representation at decision-making levels nationally and internationally. Much can be attributed to the work of former Executive member and current Life Member Veitu Diro for initiating and driving the programs of Women in Sport in early 2000s.

Since 2004, the PNGOC Board consisted 40% to 60% of female representation, having earnt their position on merit. Apart from serving on the PNGOC board, Mel Donald, Karo Lelai and Auvita Rapilla have gone on to serve on the boards of the Oceania National Olympic Committees (ONOC) and the Association of National Olympic Committees

(ANOC)

In 2015, Emma Waiwai led the organisation and delivery of the 2015 Pacific Games as Chairperson of the Games Organising Committee, and in 2016 Tamzin Wardley was the first female ever elected to the Pacific Games Council Executive. Also in 2016, PNG saw its first IOC Member Auvita Rapilla elected at the 129th IOC Session in Rio de Janeiro, Brazil and currently sits on five (5) IOC Commissions.

Basketball, Fencing, Gymnastics, Netball, Shooting, Squash, Swimming, Tennis, Va'a and the PNG Olympians Association are all been led by female Presidents. Sport has a positive influence on the advancement of gender equality and provides a powerful platform for empowerment of women.

In 2019 our partnership with Government was enhanced through the signing of a memorandum of understanding (MoU) with the PNG Sports Foundation (PNGSF - the Government body responsible for Sport), which was witnessed by the IOC President Thomas Bach and then Prime Minister Hon. Peter O'Neil. The MoU clarifies areas of cooperation between both organizations and the continued strengthening of working relations between the two bodies.

We have worked hand in glove with PNGSF in delivering the Oceania Sport Education Program (OSEP) to develop and educate coaches, officials, administrators, team managers and sports science personnel throughout PNG.

As the PNGOC has grown over the years, so too has our efforts to mobilise resources for Team PNG to prepare and participate in international events. Along with funds raised from the Trukai Fun Run and Prime Ministers Corporate Golf Challenges, the PNGOC has relied heavily on corporate sponsorships, government and donor grants, and IOC funding.

Recognising our sporting heroes is an important part of inspiring others and we have been fortunate to have the tremendous support of SP Brewery as major sponsor of the SP Sports Awards since its inception in 1992.

To honor and preserve the legacy of individuals, we have recognized 17 sporting legends inducted into the PNG Sports Hall of Fame since 2011.

In the last decade, our role in community outreach has expanded significantly with programmes such as the Olympic Values Education Program, Team PNG HERO Program, Gender Equity program and other sport for development programs. A total of 105 elite athletes have been trained as Team PNG Heroes who have gone onto be agents of change to help build a better PNG through Sport.

The Papua New Guinea Olympic Committee firmly believes in the importance of having athletes at the center of everything it does. We see Team PNG as the driver to "Inspire and Unite Papua New Guinea through Sporting Excellence and Success".

HERO, which stands for the PNG Olympic Committee's values of Honesty, Excellence, Respect and Openness, trains and equips Team PNG athletes with the knowledge and skills to be role models for their sport and their communities.

Every year our activities linked to Olympic Day on June 23rd provide an opportunity for the PNGOC and our HERO athletes to promote Olympism – a philosophy of life, which places sport at the service of humankind.

In recent years, more emphasis has been placed on athlete welfare and well-being, athlete safe-guarding and transition to life after sport as focal areas to support our athletes. The adoption of the Athletes Safeguarding Policy and Declaration on Athletes Rights and Responsibilities reaffirms our commitment in supporting athletes during their sporting and non-sporting career.

Ryan Pini was elected Athlete's Representative by athletes at the 2015 and 2019 Pacific Games to serve on the Pacific Games Council Executive. Karo Lelai serves as Chairperson of the ONOC Athletes Commission and ANOC Athletes Commission. Our athlete leaders have served well in leading Athletes Commissions nationally, regionally and globally and ensuring the 'Athletes Voices' are heard.

Whilst the elusive goal of winning an Olympic medal remains in the distant future, Team PNG have stood tall on top of the podium at every level of multi-Games including the Commonwealth, Pacific Games and Pacific Mini Games.

We saw how the power of sport inspired and united our nation during the 2015 Pacific Games and also the 1991 Games when Team PNG finished on top of the medal tally. Team PNG's excellence captivated everyone into one people, one nation, showing that sport is a powerful tool for national identity and patriotic unity. Our nation was truly captivated. National pride was real. National identity became enhanced.

In Team PNG, we work to build a culture of one team with all members of the Team, male and female, doing their part, having the opportunity to excel and achieve for their team and their country.

A legacy of the 2015 Pacific Games was the Team PNG High Performance Training Centre set up by the PNG Olympic Committee to provide high performance services for our elite athletes and teams with dedicated sport science and sports medicine support. This facility now sits under the PNG Sports Foundation as High-Performance Sport PNG.

The most significant development for the PNGOC was the realisation of a long-held dream to acquire its operations headquarters, of which saw IOC President Thomas Bach in country to officially open the PNG Olympic Haus on 9th May 2019.

We value our strong relationship, continued partnership and support from the National Government and the PNG Sports Foundation. Sport can only excel with a shared approach and we look to strengthen our partnership as we work towards developing and enhancing sport in PNG under the framework of the new National Sports Policy.

Achievements over the years would not have been possible without the fantastic support from our family of Corporate Sponsors and partners such as: Kumul Consolidated Holdings, National Gaming Control Board, Trukai Industries, SP Brewery, Air Niugini, Brian Bell Group, PNG LNG Exxon Mobil, Coral Sea Hotels, Theodist, IBSU, The National, Media Partners, Blue 7 Team, Trophy Haus, CPL Group, Jacks PNG, Pacific Aus Sport and past sponsors including Kumul Holdings Petroleum Ltd, Capital Insurance Group and Pacific MMI.

The PNG Olympic Committee is a values-based organization, our values continue to guide us in the journey ahead. Representing the flagship of PNG sport development and international participation, the PNGOC has evolved over the last 60 years from a small group of enthusiastic volunteers, to a dedicated secretariat and fully equipped office to service its members. Drawing on the experience gained over the six decades and benefiting from the efforts of all who have worked for the PNGOC, we have been able to become a reputable organization well recognized and respected both nationally and internationally.

The strength of our organisation and commitment to serve the needs of our membership will continue to be the hallmark of PNGOC for the next 60 years and beyond.



## **KEY MILESTONES**

- 1961: Wednesday 2nd August, established as Territory of Papua and New Guinea Sports Union to enable the Territory of Papua and New Guinea to participate in the British Empire & Commonwealth Games.
- 1962: PNG/Team PNG attends its first British Empire and Commonwealth Games held in Perth, Australia since the Games started in 1930.
  PNG/Team PNG wins its first ever medal with Kenneth Hopkins bronze medal win in the Boxing 71 kg division at the British Empire & Commonwealth Games in Perth Australia.
- 1963: PNG/Team PNG participated in the inaugural (South) Pacific Games in Fiji on 29th Aug 8th Sept 1963.

  PNG/Team wins first ever gold at an international sporting event by Edward Laboran in the high jump, at the 1963 inaugural South Pacific Games in Fiji. PNG won 9 Golds, 12 Silver and 11 bronze.
- 1966 Robert Stewart wins PNG's first ever silver medal in the Shooting – Fullbore Rifle event at the 1966 British Empire & Commonwealth Games in Kingston, Jamaica.
- 1969: PNG hosts South Pacific Games in Port Moresby for the first time from 13 to 23 August,
- 1974: Papua New Guinea was accorded Olympic Status in 1974 allowing Team PNG to participate in the next Olympics.
- 1976: PNG/Team PNG attends its first Olympic Games- in Montreal, Canada in 1976.
- 1981: Oceania National Olympic Committee established with PNG as one of four founding members in 1981 with Australia, Fiji and New Zealand.
  PNG/Team PNG participated in the inaugural (South) Pacific Mini Games on July 7-9th 1981 held in Honiara, Solomon Islands.
- 1983: Inaugural Fun Run held in initial years with SP Brewery as major sponsor under its Pepsi Cola brand called the 'Pepsi Fun Run" in 1983.
- 1984: PNGOC recruits its first paid employee with John Dawanincura as Secretary General Under the auspices of PNGOC, Papua New Guinea first competed at the Paralympic Games in 1984, sending a delegation of four athletes to compete in track and field.
- 1990: PNG/Team PNG wins its first ever Gold in any Commonwealth Games, with Geua Tau when she defeated New Zealand's Millie Cecilia Khan 25-18 in lawn bowls (women's singles) during the 1990 Commonwealth Games in Auckland, New Zealand.
- 1991: PNG hosts its second South Pacific Games in Port Moresby and Lae from 7-21 September 1991. PNG/Team PNG topped the 1991 South Pacific Games tally with 44 Gold, 28 Silver and 27 Bronze medals.
- 1992: PNGOC secures SP as Sponsor of the Annual SP Sports Awards after the 1991 South Pacific Games.

- Inaugural SP Sports Awards held in 1992. Under this sponsorship the SP Sports Awards has grown in size and spectacle.
- 1998: Prime Minister's Corporate Golf Challenge began in 1998 at the Port Moresby Golf Club as a fundraising event for Team PNG patronized by the Prime Minister.
- Boxer Lynch Ipera wins Bronze in the 57kg division at the Commonwealth Games in Kuala Lumpa
- 2000: PNG Women and Sport Committee established in 2000.
  - PNG Athletes Commission established in 2000. Annual Pepsi Fun underwent name change as Trukai Industries took over sponsorship with subsequent naming rights as Trukai Fun in 2000.
  - On 27th May 2000, PNG hosted the Sydney 2000 Olympic Torch Relay in the lead up to the Sydney Olympic Games, in Australia. Former Prime Minister Sir Mekere Morauta as the 100th Torchbearer lit the cauldron at Sir John Guise Stadium presented to PNG by the Sydney Olympic Games Organizing Committee. Dika Toua, at age 16, makes history being the first female athlete to lift at the Olympic Games
- female athlete to lift at the Olympic Games
  2004: In 2004 the PNG National Paralympic Committee
  was established to oversee PNG's preparation and
  participation in the Paralympic Games and become
  an independent organisation of its own.
- 2005: For the very first in its history the Queens Baton visited every Commonwealth county and PNG hosted the 2006 Queens Baton Relay from 9th to 14th October 2005 in the lead up to the 2006 Melbourne Commonwealth Games.
- Prime Minister's Corporate Golf Challenge started in Lae-2005.
- 2006: Ryan Pini wins PNG's second Gold medal at the 2006 Commonwealth Games in Melbourne in the men's 100m Butterfly swimming event and Dika Toua wins Silver in the 53kg weightlifting division.
- 2007: PNG hosted the first ever Oceania Workshop on HIV and AIDS Prevention through Sport hosted in PNG in 2007 and established the HIV through Sport Committee.
- 2009: On 27th September 2009, the Pacific Games Council elected Port Moresby, Papua New Guinea to host the 2015 Pacific Games
  - Inaugural Visit by International Olympic Committee President – Jacques Rogge
- 2010: Ryan Pini wins silver medal in the 100m Butterfly event in Delhi, India. PNG/Team PNG attends inaugural Youth Olympic Games in Singapore in 2010.
- 2011: PNGOC celebrates 50 years and launched the PNG Sports Hall of Fame in 2011 to recognise past sporting excellence and successes. Sir John Kaputin and Edward Laboran inducted as PNG's first inductees into the PNG Sports Hall of Fame.
- 2013: Queens Baton Relay held in Kavieng, PNG in the lead up to the Glasgow 2014 Commonwealth Games. Team PNG finishes on top of medal tally at the 2013 Pacific Mini Games in Wallis & Futuna.

- PNGOC awarded the Oceania Sport & Environment Award at the 10th IOC World Conference on Sport and Environment.
- 2014: PNGOC establishes High Performance Training Centre (now High Performance Sport PNG).

  Dika Toua won PNG's third Gold medal in the women's
  - 53k division and Steven Kari won PNGs 4th Gold Medal in the men's 94kg division at the 2014 Glasgow Commonwealth Games.
- 2015: Papua New Guinea host the 2015 Pacific Games in Port Moresby and Team PNG top the medal tally with 88 Gold, 70 silver and 60 bronze medals.
  - Thadeus Katua won PNG's first ever gold medal in the boxing 60kg division at the Commonwealth Youth Games held in Apia, Samoa. Violet Apisah won two bronze medals in the singles event and Team event with playing partner Mathew Stubbings in the Mixed competition.
    - PNGOC launches its Olympic Values Education Program.
    - First ever Oil Search Pacific Games Relay staged in the lead up to the 2015 Pacific Games throughout Papua New Guinea.
- 2016: Papua New Guinea Sports Anti-Doping Organisation (PNGSADO) established – June 2016. Auvita Rapilla was first ever Papua New Guinean and Pacific Island woman elected an IOC Member at 129th IOC Session in Rio de Janeiro, Brazil.
  - PNGOC launches its Team PNG Heroes 'Athlete Ambassador' Program.
- 2017: Queens Baton Relay hosted in Kimbe on 2nd December 2017 coinciding with the Closing Ceremony of the PNG Games in the lead up to Gold Coast 2018 Commonwealth Games in Australia.

  Team PNG for the first time participated in the Asian Indoor & Martial Arts Games held in Ashgabat, Turkmenistan from 17 27 September 2017.
- 2018: At the 2018 Commonwealth Games in Gold Coast, Australia, Steven Kari became Team PNG's first dual Commonwealth gold medalist in the 94kg division; Dika Toua won her second Commonwealth Silver medal in the 53kg division and Morea Baru won his first commonwealth medal with a Silver in the 62kg division
- 2019: Opening of PNG Olympic Haus by IOC President, Thomas Bach on 9th May 2019. Signing of MOU with PNG Sports Foundation, witnessed by IOC President, Thomas Bach and former Prime Minister, Peter O'Neil in Port Moresby
- 2020: First Team PNG Olympic Training Camp held in Goroka at the National Sports Institute
- 2021: Team PNG participated in postponed Tokyo 2020 Olympics held in Japan from 23rd July to 8th August 2021.
  - On 2nd August, PNGOC commemorates 60th Anniversary.




